

FOR CONSTRUCTION IN MORROW COUNTY

I. DWELLINGS

NEW SITE:

1. Zoning Permit - County Planning Dept.
2. Sanitation Approval - Umatilla County Public Health (for on-site septic system)
3. Access Permit (Road) - Morrow County Public Works
4. Rural Address - County Planning Dept.
5. Building Permits (including Electrical, Mechanical, and Plumbing) - City of Boardman Building Dept.
6. Manufactured Home Set-up Permit (*if manufactured*) - City of Boardman Building Dept.

REPLACEMENT ON EXISTING SITE:

1. Zoning Permit - County Planning Dept.
2. Sanitation Approval - Umatilla County Public Health (for on-site septic)
3. Building Permits (including Electrical, Mechanical, and Plumbing) - City of Boardman Building Dept.
4. Manufactured Home Set-up Permit (*if manufactured*) - City of Boardman Building Dept.

MANUFACTURED HOME PARK:

1. Zoning Permit - County Planning Dept.
2. Sanitation Approval - the City (if on a municipal sewer system), or from Umatilla County Public Health (if on a septic tank/drain field system for sewage disposal.)
3. Manufactured Home Set-up Permit - City of Boardman Building Dept.

II. OTHER CONSTRUCTION

1. Zoning Permit - County Planning Dept. (OVER 120 SQ. FT.)
2. Sanitation Approval (if needed) - Umatilla County Public Health or Oregon Department of Environmental Quality if system is over 2,500 gallons per day
3. Electrical, Mechanical, Plumbing and Building Permits - City of Boardman Building Dept. (BUILDING PERMITS NEEDED OVER 200 SQ. FT.)

Note: The signature on the manufactured home set-up permit application should be the party doing the work. Construction Contractor's Board Registration is required for any Contractor or Manufactured Home Dealer setting up your manufactured home.

Manufactured homes sited in Morrow County outside of a Manufactured Home Park must be manufactured no more than ten years before the receipt date of the siting request application by the Planning Department and bear the Oregon Department of Commerce 'Insignia of Compliance' and meet the standards set forth in Article 4 Section 4.110 of the Morrow County Zoning Ordinance.
