ORDINANCE NUMBER MC-C-2-93.

The County of Morrow does ordain as follows:

WHEREAS, Morrow County's Comprehensive Plan was acknowledged by the State of Oregon on January 30, 1986; and

WHEREAS, the Morrow County Court has reviewed the recommendations of the Morrow County Planning Commission, and held a public hearing on April 14, 1993; and

WHEREAS, said Planning Commission has held two public hearings on January 4 and 25, 1993; and

WHEREAS, no appeals or objections have been filed or recorded as a result of said hearings (three hearings);

NOW THEREFORE, be it ordered by the Morrow County Court that the attached map marked exhibit "A" amending the Morrow County Zoning Map for the above-mentioned property be, and is hereby made, a part of the Morrow County Comprehensive Plan rezoning a 5.62 acre portion of Tax Lot 200 from E.F.U. to Rural Residential One Acre.

This Ordinance shall take effect upon a unanimous vote of the County Court and the passage of ten (10) consecutive working days and the attestation by the Morrow County Clerk.

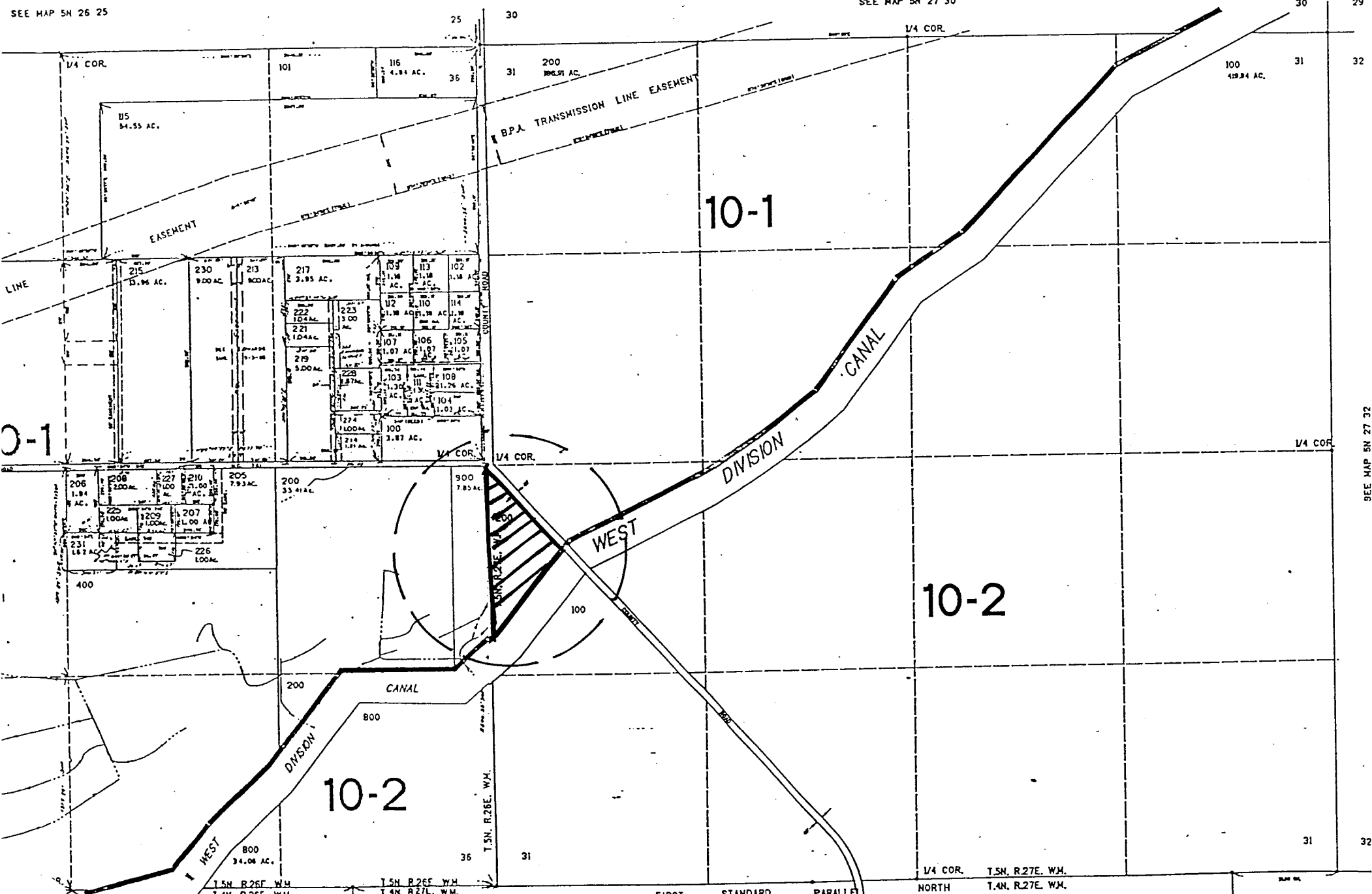
