ORDINANCE NUMBER MC-C-5-97

The County of Morrow does ordain as follows;

WHEREAS, the Morrow County Planning Commission reviewed the combined Conditional Use Permit and Comprehensive Plan Amendment application filed by the Morrow County Public Works Department, to establish a new quarry site in the Lunceford Canyon area; and

WHEREAS, the Morrow County Planning Commission held public hearings on May 9, 1997 at Lexington, Oregon and June 30, 1997 at Irrigon, Oregon;

WHEREAS, the Morrow County Planning Commission voted unanimously to approve the Conditional Use Permit to operate the County rock crusher and to amend the comprehensive plan to include the site on the Goal 5 aggregate inventory; and

WHEREAS, the Morrow County Court reviewed the recommendation for approval by the Morrow County Planning Commission and voted unanimously to uphold the decision of the Planning Commission; and

WHEREAS, the Morrow County Court held a public hearing on July 2, 1997 at Heppner, Oregon.

SECTION 1. TITLE OF ORDINANCE.


This ordinance shall be known, and may be cited as, "the Comprehensive Plan Goal 5 Amendment for the Thompson Aggregate Site"
