This matter coming before the County Court for Morrow County, sitting as the county governing body, at a regularly scheduled meeting on the 21st day of October, 1992; and

Whereas, inadequate time has been allowed to permit Morrow County to present the proposed rules to the citizens of Morrow County and obtain their input prior to LCDC's contemplated adoption date because of the "fast-track" procedures employed in this matter; and

Whereas, initial analysis of the proposed rules by professional staff reveals that the effect of the "formula approach" of proposed rules, if implemented, would create undue hardship for the citizens of Morrow County and would inhibit legitimate uses of Morrow County lands; and

Whereas, the procedural aspects of the proposed rules would essentially remove most discretion and flexibility from the local Planning Department, Planning Commission and local citizens regarding farm and forest land uses, all to the detriment of the citizens of Morrow County; and

Whereas, it appears that the statewide variations in geography, soil type, forest and farm practices, population density, population distribution, transportation patterns, rainfall and local economic bases are so great as to preclude the practicality of statewide formula criteria for determining appropriate land conservation and development uses in particular localities;

NOW, THEREFORE, IT IS RESOLVED that Morrow County intends to, and hereby does, reject DLCD's proposed rules regarding farm and forest uses and establishing Small Scale Resource Lands in their entirety; it is further

RESOLVED that Morrow County will continue to reject these rules, and any revisions thereof, which purport to legitimately regulate land use by application of statewide formula criteria; it is further

RESOLVED, that Morrow County will continue to reject these rules, and any revisions thereof, which are promulgated with such haste that informed citizen input is avoided.
