WHEREAS, the Morrow County Board of Commissioners held a public hearing on February 21, 2024 and voted to approve the application; and

WHEREAS, the Morrow County Board of Commissioners held a public hearing on March 6, 2024 and conducted a second reading of the ordinance.

NOW THEREFORE THE MORROW COUNTY BOARD OF COMMISSIONERS ORDAINS AS FOLLOWS THAT THE MORROW COUNTY BOARD OF COMMISSIONERS AMENDS THE COMPREHENSIVE PLAN TO CHANGE THE COMPREHENSIVE PLAN MAP FROM RESIDENTIAL TO COMMERCIAL AND TO CHANGE THE ZONING MAP OF A 1.54 ACRE PARCEL OF LAND FROM SUBURBAN RESIDENTIAL 2 TO GENERAL COMMERCIAL.
