

# OREGON CORNER RESTORATION REPORT

**CORNER DESIGNATION:** T1N, R26E, Z-7

SOUTH 1/4 CORNER OF SECTION 32, TOWNSHIP 1 NORTH, RANGE 26 EAST, W.M., MORROW COUNTY, OREGON.

**PREVIOUS RENEWALS / SURVEYS, ETC.:**

THE BASELINE WAS ORIGINALLY SURVEYED BY THOMPSON IN 1859 AND WAS RESURVEYED BY HAFT UNDER CONTRACT NO. 99, DATED JULY 8, 1861 IN WHICH THE NOTES READ, "DEPOSITED A PINT OF CHARCOAL AND SET A POST FOR QR. SEC. CORNER & RAISED A MOUND WITH TRENCH AND PITS AS PER INSTRUCTIONS".

**MONUMENT AND ACCESSORIES FOUND:**

NO EVIDENCE OF THE HAFT CORNER REMAINS. THE AREA HAS BEEN DISTURBED BY FARMING ACTIVITY. I HELD THE AVERAGED CENTERLINE OF BASELINE LN. TO THE NORTH AND WEST AND EXTENDED SOUTH AND EAST BY BEARING-BEARING INTERSECTION. ORIGINAL ROAD NOTES (#224) CALL TO FOLLOW SECTION LINES AND CORNERS IN THIS LOCATION; THEREFORE, THE ROAD WAS HELD AS BEST AVAILABLE EVIDENCE.

**MONUMENT AND ACCESSORIES SET:**

SET 2-1/2" BRASS CAP ON 1" I.D. X 30" GALVANIZED IRON PIPE WITH FLARED BOTTOM, MARKED AS SHOWN IN DETAIL BELOW. ESTABLISHED 4 REFERENCE MONUMENTS AS FURTHER DESCRIBED AND DETAILED BELOW.



**LOCATION / COMMENTS:**

FROM INTERSECTION OF HWY 207 AND BASELINE LN., TRAVEL EASTERLY DOWN BASELINE LN. FOR ±2.10 MILES. CORNER IS AT THE EDGE OF A WHEAT FIELD AT THE SOUTHERLY AND EASTERLY EXTENSION OF THE BASELINE LN CENTERLINE.
