MONUMENT AND ACCESSORIES FOUND: Found 15"x15"x8" irregular shaped and very porous stone laying flat, buried 4" below ground level, 1.0 foot East of the buried end of an old locust H-Brace fence corner post. No visible marks could be located on the stone, however it is of correct size and it is the only stone in the area of the corner. The fence corner posts' top is leaning Westerly with H-Braces extending North and East. A farmed field berm extends North and East from the fence corner post.

MONUMENT SET: At the center point of the found stone, set a 2 3/8" diameter brass cap on a 1 1/4"x30" galvanized iron pipe with the top of the cap flush with the ground surface. Buried the found stone on the West side of the brass cap monument next to the locust fence corner post. Monument marked as shown in "Monument Marking Detail".

A 5/8"x30" iron rebar with 1 1/4" diameter blue plastic cap marked "Wells Surveying PLS 54657" with the top buried 22" below ground level in a CRP field bears: North 59°45' East a distance

A 5/8"x30" iron rebar with 1 1/4" diameter blue plastic cap marked "Wells Surveying PLS 54657" with the top buried 22" below ground level in a farmed field bears: South 39°21' East a distance of 29.8 feet.

A 5/8"x30" iron rebar with 1 1/4" diameter blue plastic cap marked "Wells Surveying PLS 54657" with the top buried 22" below ground level in a farmed field bears: South 59°18' West a distance of 36.4 feet.
