THE ORIGINAL CORNER SET BY U.S. DEPUTY SURVEYOR E.E.HAFT IN 1861. HE SET A CHARRED STAKE & RAISED A MOUND WITH TRENCHES. OTIS GOULD CONDUCTED A DEPENDENT RESURVEY COMPLETED IN 1941. AT THAT TIME HE FOUND THE REMAINS OF AN OLD STAKE WITH INCOMPLETE SCRIBE MARKS, AND SET A 2" DIAMETER 3' LONG IRON POST WITH A BRASS CAP AND DUG PITS.IN THE EARLY 1970'S ROGERS SURVEYING INC. SURVEYED THIS CORNER AS PART OF WORK FOR DEVELOPMENT OF SABRE FARMS (SEE SURVEY 2016-1759C).

MONUMENT and ACCESSORIES FOUND: (CONDITION AND SOURCE)

AT THE CORNER POSITION WE FIND THE 1939 GLO MONUMENT BENT APPROXIMATELY 90°. WE STRAIGHTEN THE MONUMENT AT THE POINT OF DISTURBANCE AND CONFIRM IT IS IN IT'S ORIGINAL POSITION BY COMPARING TO OUR 1973 SURVEY, USING A GRANT **BOUNDARY METHOD AGAINST CORNERS TO THE WEST & SOUTH**
