

# OREGON CORNER RESTORATION REPORT

**CORNER DESIGNATION:** T3S, R26E, N-9

SECTION CORNER COMMON TO SECTIONS 16, 17, 20, & 21, T3S, R26E, W.M., MORROW COUNTY, OREGON.

**PREVIOUS RENEWALS / SURVEYS, ETC.:**

T3S, R26E WAS ORIGINALLY SURVEYED BY GEORGE WILLIAMS UNDER CONTRACT NO. 176, DATED JULY 20, 1872 IN WHICH THE NOTES READ, "SET STONE 14X8X7 FOR CORNER TO SECTIONS 16, 17, 20, 21".

**MONUMENT AND ACCESSORIES FOUND:**

NO EVIDENCE OF THE ORIGINAL STONE WAS FOUND. CORNER FALLS IN THE CENTER OF STOCK DRIVE RD. ORIGINAL ROAD NOTES (APPLICATION #45) CALL TO THIS SECTION CORNER. HELD AVERAGED ROAD CENTERLINE FOR DEPARTURE AND THE AVERAGE OF ROCK JACK LOCATIONS EXISTING EAST AND WEST OF THE ROAD FOR LATITUDE. WESTERLY JACK IS PARTIALLY DESTROYED AND STANDING ALONE. EASTERLY JACK IS IN GOOD CONDITION WITH FENCE EXTENDING SOUTH AND EAST.

**MONUMENT AND ACCESSORIES SET:**

SET 2-1/2" BRASS CAP ON 1" I.D. X 30" GALVANIZED IRON PIPE ±6" UNDER THE GRAVEL ROAD SURFACE, MARKED AS SHOWN IN DETAIL BELOW. ESTABLISHED 4 REFERENCE MONUMENTS AS FURTHER DESCRIBED AND DETAILED BELOW.



**LOCATION / COMMENTS:**

FROM HEPPNER, OR TRAVEL SOUTHERLY ALONG HIGHWAY 206 FOR ±4.5 MILES TO STOCK DRIVE RD. THENCE ALONG STOCK DRIVE ROAD, TRAVEL WEST ±0.4 MILES THEN SOUTH 0.5 MILES TO THE CORNER.
