

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

INDEX No. V-23

History of original corner establishment:

Corner originally established in 1884, by Frank W. Campbell, under General Land Office Contract No. 507. Surveyor General's Notes state: Set a basalt stone 10x10x7 ins., 7 lbs. in the ground for 1/4 sec. cor., marked, 1/4 on N face, from which

A fir 20 ins. in dia. bears N49°W., 22 lks. dist. marked, 1/4 S BT A fir 16 ins. in dia. bears S 2°E., 19 lks. dist. marked, 1/4 S BT

Description of corner evidence found:


Found a 10"x10"x8" stone, lying loose, with marks visible, but not legible, lying westerly downhill 5 ft. from corner position as determined at record measurement from the original Bearing Trees.

Found a Fir 32" dia., live, with double blaze healed over, Bears Record N49°W., 14.5 ft., from a point. Found a Fir 30" dia., live, with double blaze healed over, Bears Record S 2°E., 12.5 ft., from a point. Accepted this said point as the 1/4 corner position.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set 2-1/2"x30" aluminum pipe with 2-1/2" aluminum cap, stamped as shown on the **DIAGRAM**, SET 25" in the ground and set original stone North alongside the pipe.

From which:  
 A Fir 10" dia., bears, S86°W., 18.4 ft., scribed; 1/4 S36 BT  
 A Fir 7" dia., bears, N 7°E., 33.9 ft., scribed; 1/4 S25 BT  
 Measurements to trees taken with a metal tape and magnetic compass, with Declination set off 20 deg. East. Scribe, Bearing Nailed a brass washer stamped PLS 848 on blaze above BT scribe, Bearing Tree Sign above blaze, and warning sign on back of each tree. Painted a 6" red band at breast ht. around each tree. Set steel fence post with Warning Sign, alongside corner monument.
