

MORROW COUNTY PARTITION PLAT NO. 1992-5

In the SW 1/4 of Section 19, T5N, R27E, W.M., Morrow County, Oregon

LEGAL DESCRIPTION:

The West 140.00 feet of Lot 5, Block 7 East Excepting therefrom the South 54.00 feet thereof. Also excepting that portion lying in the relocated U.S. Highway #730 right-of-way.

EASEMENT DEDICATION:

The undersigned owners hereby dedicate the 10 foot easement for ingress and egress and the 10 foot sewer easement, as shown on this Plat, on Parcel #1 to benefit Parcel #2. Also a 25' easement to U.E.C.A. We also establish and acknowledge this Plat as the official Partition Plat of our property.

SURVEYOR'S NARRATIVE:

The purpose of this survey is to divide the above described tract into two parcels for pending sales. Parcel #1 contains a double wide mobile home and Parcel #2 contains a small house. I staked the South line of this tract in a 1977 survey for C.A. Miller. I used monuments from that survey and ones from my 1979 survey for Haney in Block 8 E to do this survey. In those surveys I tied the RR Tracks which were in at that time and which were also shown on Tamblin's 1935 plat of Part of Section 19. Everything fits relatively well with Tamblin's 1935 plat.

I had a problem establishing the Right-of-Way of U.S. Highway #730. The copy of the Right-of-Way map I acquired from the Regional Maintenance Supervisor did not show any ties to the RR Tracks or to the right-of-way of South Main as shown on Tamblin's plat. Evaluating measurements to the centerline of the existing pavement and to a questionable monument I found at approximately Station 57+00 I conclude that the South Hwy. R/W line lies about 6 feet North of the South right-of-way line of South Main Avenue as Tamblin staked it in 1935.






