

GREEN GARDEN ESTATES

A Replat of Part of Block 4W, of Tamblyn's 1935 Plat of Subdivision of Part of Section 25, T5N, R2GE, W. M., Morrow County, Oregon.
In NW 14, SE 1/4 of said Section 25.

LEGAL DESCRIPTION:

That portion of Block 4 West of the Subdivision of Part of Section 25, T5N, R2GE, W.M., Morrow County, Oregon, being described as follows:

Beginning at the Southwest corner of Lot 13, of said Block 4W and running; thence N 0°22'59"W along the West line of said Lot 13 and along the West line of Lots 12 and 9 a distance of 1086.57 feet to a point which lies 30.14 feet South of the South line of that tract of land deeded to Douglas Renoe, et ux, recorded on M-12955, Morrow County Deed Records; thence N 86°26'54"E along a fence line a distance of 301.44 feet to a point on the West line of that tract of land deeded to Myra Wright by correction deed recorded on M-17344, Morrow County Deed Records; thence S 1°36'44"E along the West line of that tract of land deeded to Myra Wright by correction deed recorded on M-17344, Morrow County Deed Records a distance of 1103.86 feet to a point on the South line of said Lot 13, Block 4 West; thence S 89°40'56"W 324.66 feet to the Point of Beginning.

SURVEYOR'S CERTIFICATE:

I, G. Dennis Edwards, do depose and say that I am a duly registered surveyor of the State of Oregon and that I have correctly surveyed and marked with legal monuments the land represented on this Plat, and the INITIAL POINT is a 5/8" rebardriven 6" below the surface at the Southwest corner of Lot 13, Block 4W of the Subdivision of Part of Section 25, T5N, R2GE, Willamette Meridian, Morrow County, Oregon.

This survey is based on one done by Dave Krumbein in 1987 in which he retraced Tamblyn's 1935 Plat of Part of Section 25. In 1980, Walt Cramer did an unrecorded survey and a Deed correction on the West line of Wright (M-17344) but Gorham's property, which I am now surveying, (M-43564) did not get changed. I have done a boundary line adjustment on said Wright's line and also on Renoe's property to the North to match existing fences.

There are full water rights on this parcel through the West Extension Irrigation District and each lot gets full water rights.
