
MORROW COUNTY PARTITION PLAT NO. 1994-



Description:

Beginning at the point of intersection of the East-West centerline of Section 9. T 4 N. R 25 E. W.M. with the West line of Olsen Road. Said point lies S 89°57'40"W 20 feet from the East Quarter Corner of said Section 9 and running: Thence S89°57'40"W along said East-West centerline 840.35 feet: Thence S0°54'55"E parallel with the East line of said Section 9 a distance of 760.50 feet to a point on the North line of "KNUDSEN COMMERCIAL PARK": Thence N83°00'40"E along said North line 844.99 feet to a point on the West line of said Olsen Road: Thence N0°54'55"W along said West line 658.24 feet to the point of Beginning.

The above described parcel is a portion of that tract of land described in a deed to C. Joseph Locke recorded on M-38513 Morrow County Deed Records.

Narrative:

The purpose of this survey is to partition one acre out of the Northeast corner of the above described parcel for the construction of mini-warehouses.

David Krumbein surveyed the North line and the East line of this parcel in a 1979 survey for L-R Land Company County survey No.D-168-K. Gary Langlitz surveyed the East line and set monuments on the South line in a 1980 survey for the City of Boardman. County survey No. C-376-K. Their bearings are the same and are what I used for this survey. Parcel No 2 is larger than 10 Acres so was not surveyed at this time.


