SURVEYOR'S CERTIFICATE:


I, G. Dennis Edwards, am a registered surveyor of the State of Oregon and have marked with legal monuments the land shown on this Plat. The purpose of this survey is for the pending sale of Parcel #1.

This parcel is described in a deed to Prouty on M-6605 and gives no reference to Block 7E of the Subdivision of Section 19, by Tamlyn or to Block 42 of the Town of Irrigon or to vacated Twelfth Street, all of which this tract is part of. No mention to any of the above are in the deeds to Horner and Columbia View Church.

The South line of this parcel was surveyed by me in a 1987 survey for Prouty, the East line was established by "LOCUST SUBDIVISION" and by my 1992-5 Partition Plat. I found an iron pipe at the Northwest corner of Block 42 of the Town of Irrigon.

The DESCRIPTION of this tract is as follows:
Beginning at the Southeast corner of Lot 1 of Block 7E of the Subdivision of Section 19, T5N, R27E, W.M., Morrow County, Oregon and running; thence North along the East line of said Lot 1 and along the East line of Lots 2, 3 and 4 a distance of 774.11 feet to a 5/8" rebar which lies 239.53 feet South of the Northeast corner of said Lot 4, Block 7E, thence S 76° 08' 10" W 561.64' (556.00) feet to a 5/8" rebar on the East line of Eleventh Street which lies 240.00 feet South of the Northwest corner of Block 42 of the Town, now City of Irrigon; thence S 0° 26' 38" E along the East line of Eleventh Street 636.89 feet to a point on the North line of Idaho Street; thence S 89° 43' 09" E along said North line 543.20 feet to the Point of Beginning.

Also that portion of vacated Idaho Street lying South of said Block 42 of the City of Irrigon and South of vacated Twelfth Street.


