NARRATIVE OF SURVEY


THE PURPOSE OF THIS SURVEY WAS TO MONUMENT THE EXTERIORS OF PARCELS #1 AND #2 FOR BOUNDARY ADJUSTMENT PURPOSES AFTER IT WAS DETERMINED THAT EXISTING IMPROVEMENTS (CABINS) WERE NOT ON THE PROPERTY DESCRIBED IN DEEDS (BOOK 44, PAGE 521, MORROW COUNTY DEED RECORDS, PARCEL #1; BOOK 50 PAGE 476, MORROW COUNTY DEED RECORDS, PARCEL #2). THE COUNTY ROAD RIGHT-OF-WAY INTERSECTIONS WERE ALSO MONUMENTED ON PARCEL #1, AS ESTABLISHED BY TIES TO RIGHT-OF-WAY FENCE CORNERS AND EDGES OF PAVEMENT (SEVERAL RED-TOP HUBS STILL REMAIN FROM ROAD CONSTRUCTION) AND ROTATING IT TO OUR SURVEY. THE COUNTY ROAD (WILLOW CREEK ROAD) RIGHT-OF-WAY MAP (D-634-K-633) SHOWS NO RIGHT-OF-WAY MONUMENTS IN THIS AREA, AND SHOWS A STATION TIE OF 965+36.64 P.O.C., 72.82 LT. TO THE EAST 1/16 C-C OF SECTION 21 (SUPPOSEDLY A STONE). FERGUSON REMONUMENTED THE AREA AFTER THE LOCATION SURVEY AND DEEDS FOR THE ROAD WERE COMPLETED (MORROW CO. SURVEY #D-802-K-#652, HERREN CADASTRAL SURVEY FOR UMATILLA NATIONAL FOREST, APPROVED JUNE, 1985) AND HIS MONUMENTS AT THE S.E. 1/16TH AND THE 50.00-FOOT REFERENCE TO THE E. 1/16TH C-C WERE USED FOR THIS SURVEY, AND THE BEARING HE SHOWS BETWEEN THE TWO WAS USED FOR A BEARING BASE FOR THIS SURVEY. NO STONE WITH ANY MARKINGS WAS FOUND AT THE LOCATION SHOWN FOR THE E 1/16TH C-C ON THE ROAD R/W MAP. MONUMENTS SET ON PARCEL #1 ON THE ROAD RIGHT-OF-WAY INTERSECTION POINTS MATCHED IMPROVEMENTS (FENCES) VERY WELL.

AT OUR CLIENTS REQUEST, EXISTING POSSESSION LINES (FENCES) WERE HELD AND THE EASTERLY PROPERTY LINES WERE MONUMENTED ON THE WEST LINE OF THE NE 1/4 OF THE SE 1/4 OF SECTION 21 AS ESTABLISHED BY FERGUSON'S SURVEY, WHICH WILL RESULT IN WILKINSON (PARCEL #3) DEEDING GREEN (PARCEL #1) 3.11 ACRES; WILKINSON (PARCEL #3) DEEDING VAN WINKLE (PARCEL #2) 2.55 ACRES; AND VAN WINKLE (PARCEL #2) DEEDING WILKINSON (PARCEL #3) 0.02 ACRES.

THE EASEMENT SHOWN THROUGH PARCEL #1 AND THE NORTHWEST CORNER OF THE EXISTING PROPERTY BOUNDARY OF PARCEL #2 WAS ESTABLISHED IN BOOK 39. PAGE 409 OF THE MORROW COUNTY DEED RECORDS, THOUGH NO WIDTH OR METES AND BOUNDS DESCRIPTION WAS GIVEN. THE EXISTING USED ROAD CENTERLINE IS DESCRIBED IN THE EASEMENT DATA TABLE AND THE REMAINDER OF THE EASEMENT THROUGH PARCEL #2 WILL BE ESTABLISHED IN THE DEED FROM WILKINSON TO VAN WINKLE. WIDTH IS SHOWN AT 20 FEET, AS NO WIDER ACCESS COULD BE BUILT DUE TO LIMITAIONS FROM THE NEW COUNTY ROAD RIGHT-OF-WAY, WILLOW CREEK, AND CABIN

A CLOSED TRAVERSE WAS USED TO ESTABLISH LOCATION ON THE 1/16TH CORNER MONUMENTS AND PROPERTY BOUNDARIES, AND WAS ADJUSTED BY THE COMPASS RULE. PROPERTY LINE MONUMENTS WERE SET USING RADIAL TIES FROM TRAVERSE POINTS. INSTRUMENT USED WAS A NIKON NTD-4 MANUAL TOTAL STATION.
