

NARRATIVE: From Original Plat

This survey is based on the survey for Desert Delight Acres in Morrow County. The centerline of Eighth Street West along the West side of Desert Delight Acres was the Basis of Bearing for this survey. established the boudaries of the Parcels 10 and 11 by the found monuments and the Deed Description. I then separated the East 67.00 feet of Parcel 11 to be adjusted into the adjacent 188.00 foot lot. The remaining land was then divided into three separate lots. A 15.00 feet easement is present along the North side of the original Parcels 10 & 11 as was an Easement for the B.P.A. Transmission Line.

NARRATIVE: For Lot Line Adjustment

Mr. Gale needed to adjust the lot Lines of the Original Plat to accomodate the sale of a parcel without leaving improvements on or near an adjacent lot or lot line. I was the surveyor for the Original Plat and therefore changed my original work to reflect the changes required to meet both Mr. Gale and the County Planning Departments requirements for set-backs. I adjusted the lot line between Parcels 2 & 3 by moving it 40.00 feet South and parallel to its existing location. I have shown both the Original and Adjusted lines for the adjusted lots.
