## SURVEYOR'S NARRATIVE

THIS SURVEY WAS MADE AT THE REQUEST OF TRACY THOMPSON OF COLUMBIA DEVELOPMENTS, L.L.C., TO DIVIDE A TRACT OF LAND INTO THREE PARCELS.

CONTROLLING MONUMENTS FOUND AND THOSE ESTABLISHED ARE NOTED.

NO RECORD OF DEDICATION FOR THE RIGHT-OF-WAY OF WILLOW FORK DRIVE, EAST OF THE EAST LINE OF THE COLUMBIA TERRACE PLAT, WAS FOUND IN COUNTY RECORDS. THE ALIGNMENT OF WILLOW FORK DRIVE, EAST OF THE EAST LINE OF THE COLUMBIA TERRACE PLAT IS SHOWN PER "WORK MAP" PREPARED BY ROGERS SURVEYING INC., DATED SEPTEMBER, 1977, AND FOUND IN THE OFFICE OF TOM MCELLIGOTT OF MORROW COUNTY ABSTRACT AND TITLE COMPANY. SAID ALIGNMENT OF WILLOW FORK DRIVE FITS EXISTING IMPROVEMENTS, WHICH CONSIST, IN PART, OF SANITARY SEWER, WATER AND STORM SEWER LINES AND A 42 FOOT WIDE PAVED STREET WITH 2 FOOT CURB AND GUTTER SECTIONS ON EACH SIDE OF STREET.

THIS SURVEY WAS MADE WITH LEICA 399 GEODETIC GPS RECEIVERS USING STATIC AND REAL TIME KINEMATIC METHODS. A SOKKIA SET 4B FIVE SECOND TOTAL STATION WAS USED IN AREAS WHERE VEGETATION OBSCURED GPS SIGNAL RECEPTION.
