

Thence North 89° 21' 54" West 376 feet to the True Point of Beginning.

NARRATIVE:

This survey is based on my survey for DeVane (P.P. 1995-5B) and Morrow County survey by Krumbein C.S. #D-303-K, 1980. Krumbein found the Original Concrete Monuments at the intersections of Washington Street and Fifth and Sixth Streets. He set 5/8" Iron pins with Aluminum Caps at these Original Monument locations. I used the found caps set by Krumbein to establish the Southwest corner of Block 35 W in order to partition the Devane and Dooney property. I used the Deed Distances to establish the corners of the original property and then divided this property into two parcels. I found pins set by Ming along the West side of the property and according to the filed survey for those pins, the distance in the deed called as N 89° 20' 41" E, 34.50' the actual distance should have been 24.50 feet .The pins did not exactly match the distances from the Southwest corner of Block 35 W, so I noted their position in respects to my calculated lot corners. The Basis of Bearing for this survey was the centerline of Washington Street as found between the Krumbein monuments at Fifth and Sixth Streets. The Original Subdivision that created Block 35 West by Tamblyn established the location of the Block corners only, it did not locate any Lot Lines with respect to this or the DeVane lot deed descriptions.
