SURVEYOR'S NARRATIVE:

THE PURPOSE OF THIS PARTITION PLAT IS TO PARTITION OUT A 6 ACRE HOMESITE FROM THE TRACT DESCRIBED BELOW.

AS PARCEL I OF THIS PLAT IS GREATER THAN 10 ACRES A A BOUNDARY SURVEY IS NOT REQUIRED. THERFORE PARCEL I WAS

THE BEARINGS ARE BASED UPON 1983 STATE PLANE COORDINATES DERIVED FROM STATIC GPS SESSIONS AND ROTATED TO TRUE AROUND THE POINT OF BEGINNING OF PARCEL 2 WHICH IS THE 5/8" X 30" STEEL REBAR WITH A PLASTIC CAP MARKED LS 2850 LOCATED AT THE SOUTHEAST CORNER OF PARCEL 2, USING A THETA OF 00" 25" 08" AND A COMBINATION FACTOR OF 0.999841.




