

SURVEYORS NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO SET MONUMENTS AND PREPARE A DESCRIPTION FOR THE 5 ACRE TRACT SHOWN. THIS WAS REQUIRED FOR FINANCIAL PURPOSES ONLY AND THIS PLAT IS NOT. NOR IS INTENDED TO REPRESENT AN APPROVED MORROW COUNTY PARTITION PLAT.

THE SECTION CORNER SHOWN IS A STONE WHICH WAS FOUND 3 FEET EAST OF AN ERODED STONE MOUND. ALTHOUGH THE FOUND STONE'S DIMENSIONS DID MATCH THE 1865 RECORD BY THOMPSON. NO NOTCHES GROOVES OR ANY OTHER DISCERNABLE MARKINGS WERE FOUND ON THAT STONE.

THENCE S 70° 18' 54" W 500.49 FEET TO A 5/8" STEEL REBAR SET ON THE SOUTHERLY RIGHT OF WAY OF JORDAN CANYON ROAD. BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION:

THENCE \$ 10° 39' 30" W 484.82 FEET TO A 5/8" STEEL REBAR;

THENCE N 86° 42' 29" W 175.65 FEET TO A 5/8" STEEL REBAR:

THENCE N 64° 47' 14" W 285.76 FEET TO A 5/8" STEEL REBAR:

THENCE N 16° 20° 32° W 283.19 FEET TO A 5/8° STEEL REBAR SET ON THE SOUTHERLY RIGHT OF WAY OF HALVORSEN LANE. (JORDAN CANYON ROAD):

THENCE ALONG THE SOUTHERLY RIGHT OF WAY OF HALVORSEN LANE THE FOLLOWING BEARINGS AND DISTANCES:

THENCE N 73° 39' 28" E 147.35 FEET TO A 5/8" STEEL REBAR:

THENCE ALONG THE ARC OF A 997.51 FOOT RADIUS CURVE TO THE RIGHT 342.66 FEET. THE CHORD OF WHICH BEARS N 83° 29' 55" E 340.98 FEET:

THENCE S 86° 39° 38° E 123.28 FEET TO THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION.
