THIS SURVEY WAS PERFORMED AT THE REQUEST OF JANEAL CASTELLAW FOR HER FATHER AND MOTHER CALVIN AND MARGARET PRICE. THE PURPOSE OF THE SURVEY IS TO PERFORM A LOT LINE ADJUSTMENT BETWEEN TWO ADJOINING PROPERTIES KNOWN AS TAX LOT 707 (RAMIREZ, 2003-7537) AND TAX LOT 702 (PRICE, M9624, M10870). TO PERFORM A LOT TOWN AS TAX LOT 707 (RAMIREZ, 2003-7537) AND TAX LOT 702 (PRICE, M9624, M10870). M19670) TO ENCOMPASS AN EXITING DRIVEWAY ONTO TAX LOT 707 (RAMIREZ, 2003-7537).

THIS FIRM PREVIOUSLY PERFORMED A SURVEY IN 2001 ON TAX LOT 707, AND I HAVE RECOVERED THOSE
