

PROPERTY DESCRIPTION:

The East 67 feet of the following described parcel of land, being a portion of Lot 10 of VACATED DESERT DELIGHT ACRES, in the County of Morrow, State of Oregon;

Thence South 00°02'15" West, 658.88 feet;

Thence South 89°48'40" West along the Southerly line of said Lot 10, 188.00 feet;

Thence North 00°02'15" East, 658.96 feet to the True Point of Beginning.

I, Ronald V. Mckinnis, being a Registered Professional Land Surveyor of the State of Oregon, certify that I have correctly surveyed and monumented the lands portrayed on this Plat according to ORS Chapter 92 of the State of Oregon.

This survey is based on my survey for Gale in the Desert Delight Acres in Morrow County. The centerline of Eighth Street West along the West side of Desert Delight Acres was the Basis of Bearing for that survey and this survey.

I originally established the boundaries of the Parcels by the found monuments and the Deed Description. In this survey I have eliminated the line between Parcel 2 and the adjacent 67.00' strip of land to the East. The remaining parcels have not changed.
