THIS PARTITION WAS PREPARED AT THE REQUEST OF THE OWNERS. THE PURPOSE OF THE PARTITION IS TO MAP PARCELS 1, 2 AND 3, SHOWN ON SHEET 1 OF 2. NO GROUND SURVEY WAS PERFORMED. RECORD OWNERSHIP DOCUMENTS AND EASEMENT DOCUMENTS WERE PROVIDED BY MIKE GLAVEY AND MID-COLUMBIA TITLE COMPANY.

REVERSIONARY RIGHTS TO PORTIONS OF COUNTY AND OR PUBLIC ROADS ARE CONTROLLED BY STATE STATUTE. BOUNDING LINES SHOWN ON THIS PARTITION PLAT ARE NOT INTENDED TO LIMIT STATUTORY REVERSION RIGHTS WITHIN THE PARTITION PLAT AREA.
