

SURVEYOR'S NARRATIVE

THIS SURVEY WAS UNDERTAKEN IN AUGUST OF 2010 AT THE REQUEST OF GERALD BREAZEALE. CITY OF IRRIGON MANAGER. THE PURPOSE OF THE SURVEY IS TO PERFORM A LOT LINE ADJUSTMENT BETWEEN TAX LOTS 5300 & 5401 FOR THE PROPOSED CONSTRUCTION OF THE IRRIGON LIBRARY. THE PROPERTY IS LOCATED IN A PORTION OF SECTION 24, TOWNSHIP 5 NORTH, RANGE 26, EAST OF THE WILLAMETTE MERIDIAN, IRRIGON, OREGON. THE PROPERTY WAS DEEDED TO THE CITY OF IRRIGON ON M-15300. MORROW COUNTY RECORDS.

THE INITIAL CONTROL POINTS UTILIZED FOR THIS PROJECT ARE THE FOUND 3" BRASS CAP MARKING THE SOUTH 1/16 CORNER OF SECTIONS 19 AND 20, TOWNSHIP 5 NORTH, RANGE 27, EAST OF THE W.M. AND THE 1" ALUMINUM CAP MARKING THE EAST 1/16 CORNER OF SECTIONS 24 AND 25, TOWNSHIP 5 NORTH, RANGE 26, EAST OF THE W.M. ALL HORIZONTAL COORDINATES ARE IN OREGON STATE PLANE, NORTH ZONE NAD 83(91) AND ELEVATIONS ARE BASED ON NAVD 88.

THIS SURVEY WAS ACCOMPLISHED USING THE TRIMBLE S6 ROBOTIC TOTAL STATION. I WAS ABLE TO PERFORM A 3 POINT RESECTION TO ESTABLISH CONTROL IN A CLOSER PROXIMITY TO THE PROJECT LOCATION.

THE BASIS OF BEARING ON THIS SURVEY ARE THE FOUND 5/8 INCH IRON RODS WITH A YELLOW PLASTIC CAP MARKED "951" MARKING THE NORTHWEST AND SOUTHWEST CORNERS OF TAX LOT NO. 5300, AND IS BASED ON A SURVEY I PREVIOUSLY DID FOR THE CITY OF IRRIGON FOR THE FUTURE CONSTRUCTION OF THE IRRIGON CITY HALL FACILITY.


