EXISTING MONUMENTS MARKING THE THE SOUTHERLY BOUNDARY OF PARCELS ONE AND TWO OF PARTITION PLAT 1999-17 WERE FOUND AND HELD FOR THE NORTH LINE OF THIS SUBDIVISION. THE WESTERLY, SOUTHERLY AND EASTERLY LINES OF THE SUBDIVISION WERE ESTABLISHED FROM THE SECTION BREAKDOWN OF THE SOUTHWEST QUARTER OF SECTION 16 AS SHOWN ON PARTITION PLAT NO. 1999-17.
