THE PURPOSE OF THIS SURVEY IS TO RESOLVE AND MONUMENT THE BOUNDARY OF THOSE TRACTS OF LAND ACQUIRED BY THE STATE OF OREGON BY WARRANTY DEEDS RECORDED IN BOOK 38, PAGE 593, AND BOOK 57, PAGE 35, MORROW COUNTY DEED RECORDS, FOR THE OREGON DEPARTMENT OF TRANSPORTATION (ODOT) REGION 5 GEOLOGY SECTION.

TO RESOLVE THE BOUNDARY OF SAID STATE OF OREGON TRACTS, THE RECORD SHAPE OF THE BOUNDARY AS DESCRIBED IN BOOK 38, PAGE 593 AND DESCRIBED IN BOOK 57, PAGE 35 WAS RECREATED AND POSITIONED BY HOLDING THE NORTHWEST CORNER OF SAID PROPERTY A RECORD DISTANCE OF 50.00 FEET FROM RECORD STATION 1177+80 AND ROTATING SAID RECORD SHAPE TO HOLD THE NORTHEAST CORNER OF SECTION "A" AS DESCRIBED IN SAID BOOK 38, PAGE 593 RECORD DISTANCE OF 50.00 FEET FROM STATION 1180+00 AS DESCRIBED IN SAID DEED AND SHOWN IN ODOT DRG. NO. 1R-1-501. THE INTERSECTION OF THE NORTHEAST CORNER OF THAT PORTION OF THE STATE TRACT DESCRIBED IN BOOK 57, PAGE 35 WAS HELD AT INTERSECTION OF THE EASTERLY RIGHT OF WAY OF HEPPNER HIGHWAY WITH THE NORTH LINE OF THE SOUTHEAST QUARTER OF SECTION 22, T2S, R29E, WM.

TO RESOLVE THE LOCATION OF OF THE RIGHT OF WAY FOR HEPPNER HIGHWAY, THE CENTERLINE ALIGNMENT AS SHOWN ON ODOT DRG. 2B-22-2 WAS RECREATED AND POSITIONED BY BEST-FIT OF THE EXISTING EDGE PAVEMENT IN THE TANGENT SECTION ADJACENT TO THE STATE OWNED TRACTS. THE EXISTING PAVEMENT EDGES ON BOTH SIDES OF THE ROAD WERE TIED FROM A POINT APPROXIMATELY 2500' WESTERLY TO A POINT APPROXIMATELY 3500' EASTERLY OF SAID STATE OWNED TRACTS TO ENSURE A BEST FIT OF THE CENTERLINE ALIGNMENT TO THE EXISTING PAVEMENT. THE CENTERLINE ALIGNMENT AS SHOWN ON ODOT DRG. 7B-12-13 WAS ALSO RECREATED AND BEST-FIT TO THE EDGE OF PAVEMENT AND THIS ALIGNMENT FIT THE EXISTING ROAD MUCH BETTER THAN THE ALIGNMENT SHOWN IN ODOT DRG. 2B-22-B, HOWEVER, SINCE THE STATE OF OREGON TRACTS ARE DESCRIBED FROM THE CENTERLINE SHOWN ON ODOT DRG. 2B-22-2, THE ALIGNMENT SHOWN ON ODOT DRG. 7B-12-13 WAS NOT SHOWN FOR CLARITY. BOTH RESOLVED ALIGNMENTS WERE COINCIDENT IN THE TANGENT SECTION ADJACENT TO THE STATE OF OREGON QUARRY TRACTS.

CONTROL NARRATIVE

PRIMARY CONTROL WAS ESTABLISHED ON THIS PROJECT BY USING GPS AND THE ONLINE POSITIONING USER SERVICE (OPUS) TO ESTABLISH A POSITION ON POINT 500. A SUBSEQUENT RTK GPS SURVEY WAS PERFORMED USING 500 AS A BASE POINT TO ESTABLISH POSITIONS ON ALL OF THE FOUND MONUMENTS SHOWN ON THIS SURVEY.

THE BASIS OF BEARINGS FOR THIS SURVEY ARE BASED UPON GPS OBSERVATIONS. THE BEARINGS SHOWN ARE GRID BEARINGS BASED ON THE OREGON STATE PLANE COORDINATE SYSTEM, NORTH ZONE, NAD83 (2011) EPOCH 2010.

COORDINATES WERE MOVED TO GROUND BY UTILIZING A LOCAL DATUM PLANE (LDP) COORDINATE SYSTEM. TO CONVERT THE PROJECT LDP COORDINATES TO THE OREGON COORDINATE SYSTEM, NORTH ZONE, NAD83 (2011) EPOCH 2010, MULTIPLY THE VALUES BY A COMBINED FACTOR OF 0.99973627.
