

This map was prepared at the request of Mr. Louis Carlson as President of the Valby Lutheran Council. The purpose of the survey was to partition the property as shown so that the cemetery portion of the property could be transferred to the local cemetery district.

The control for this survey was the monumentation from survey D-381-K set in 1980 by Mr. Donald Staebler. Mr. Staebler monumented the northeast corner of the Church property by holding the intersection of the County Road centerline with the long term fence running along the north property line. This property has been in continuous ownership since April of 1897 with several graves in the cemetery dating to that time period. The deed for the Church property calls for the north line to be the aliquot part line. Given the long occupation and continuous use of the fence line in its present lines respectively and at the necessary distance to obtain the deeded 5
