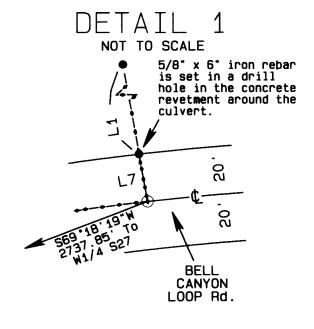
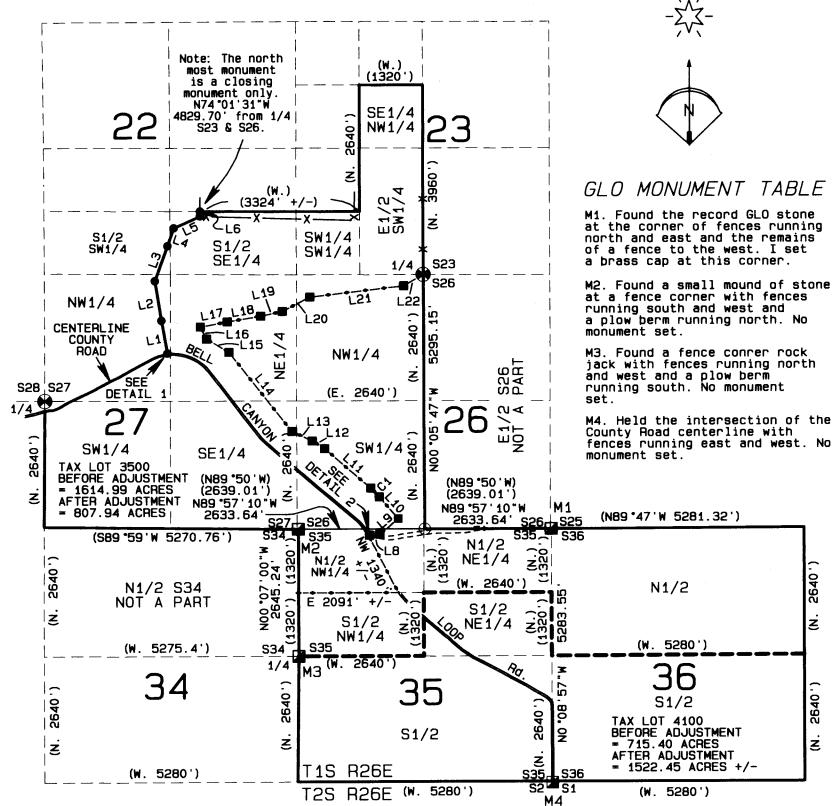
BOUNDARY ADJUSTMENT SURVEY

New Description for Tax Lot 4100:

A parcel of land located in Township 1 South, Range 26 East of the Willamette Meridian in the County of Morrow and State of Oregon, described as follows: Section 36: All.

Section 35: The South Half. The South Half of the North Half. The North Half of the Northeast Guarter.

TOGETHER WITH: All that part of the North Half of the Northwest Quarter of said Section 35, the West Half of Section 26 and the East Half of Section 27 of said Township and Range, lying East of the following described line: Beginning at the intersection of the quarter of said Section 35 with the centerline of the County Road known as Bell Canyon Loop Road; thence Northwesterly along said centerline 1340 feet, more or less, to a point which lies South 87 55'44" West a distance of 3804.07 feet from the section corner common to said Sections 26, 27, and 35 in said Township and Range; thence North 63°31'57" East a distance of 20.00 feet to a point on the northerly right of way line of said Bell Canyon Loop Road; thence North 85°18'39" East a distance of 215.55 feet; thence North 49°27'30" East a distance of 505.68 feet; thence North 41°25'09" West a distance of 598.32 feet; thence 256.42 feet along the arc of a curve to the left having a radius of 1384 feet and a central angle of 10 '36'56", the long chord of which bears North 44 '13'39" West a distance of 256.06 feet; thence North 48 56 01" West a distance of 1267.84 feet; thence North 58 13 22" West a distance of 301.08 feet; thence North 64 *32'16" West a distance of 463.56 feet; thence North 38 *24'40" West a distance of 2106.15 feet; thence North 59°25'39" West a distance of 538.10 feet; thence North 27°24'55" West a distance of 285.06 feet; thence North 79°15'19" East a distance of 572.35 feet; thence North 80°26'34" East a distance of 706.16 feet; thence North 77°54'58" East a distance of 457.98 feet; thence North 62°35'40" East a distance of 647.04 feet; thence North 83 23 15 East a distance of 1969.36 feet; thence North 60 *24'27' East a distance of 471.68 feet to the One Quarter Corner common to Sections 23 and 26 of said Township and Range, said point being the terminus of this line.

NARRATIVE OF SURVEY

This survey was performed at the request of Mr. Corey Miller. The purpose of the survey was to locate and monument the proposed division line for a boundary adjustment.

This survey utilized the same GPS control point as survey 2015–1747C. The location of the section corners shown on that survey were confirmed and ties to the additional section corners and new monumentation were made with redundant observations. Area calculations were made on the same basis as survey 2015–1747C and are based on a mixture of measured and record data. The area inside the right of way of Bell Canyon Loop Road was not included in the calculated area transferred from Tax Lot 3500 to Tax Lot 4100.

This survey was performed with a Trimble R7/R8 RTK GPS system
