

I WAS ABLE TO RECOVER 3 OF THE 5 CORNERS LS #2820 SET IN SURVEY NUMBER C-1302-M. I WAS ALSO ABLE TO RECOVER THE 4 EXTERIOR CORNERS AS SET BY LS #951 IN PARTITION PLAT 2000-7. I HELD THE 2 WESTERLY CORNERS DO TO THE FACT THAT THEY ARE THE **BLOCK CORNERS.** 

THE EXTERIOR BOUNDS OF BLOCK 5 WEST WAS EITHER FOUND OR COMPUTED AS FOLLOWS:

THE NORTHWEST CORNER OF BLOCK 5 WEST WAS FOUND AND HELD AS A 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "EDWARDS #951" FROM PARTITION PLAT 2000-7.

THE SOUTHWEST CORNER OF BLOCK 5 WEST WAS FOUND AND HELD AS A 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "EDWARDS #951" FROM PARTITION PLAT 2000-7.

THE NORTHEAST CORNER OF BLOCK 5 WEST WAS COMPUTED FROM A DISTANCE-DISTANCE INTERSECTION FROM THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "EDWARDS #951" MARKING THE NORTHWEST CORNER OF BLOCK 5 WEST AND THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "TOMKINS SURVEYING" MARKING THE SOUTHEAST CORNER OF THAT SURVEY THAT TOMKINS LAND SURVEYING COMPLETED ON SURVEY NUMBER C-1302-M.

THE SOUTHEAST CORNER OF BLOCK 5 WEST WAS COMPUTED FROM A DISTANCE INTERSECTION FROM THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "EDWARDS #951" MARKING THE SOUTHWEST CORNER OF BLOCK 5 WEST AND THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "TOMKINS SURVEYING" MARKING THE SOUTHEAST CORNER OF THAT SURVEY THAT TOMKINS LAND SURVEYING COMPLETED ON SURVEY NUMBER C-1302-M.

THE NORTHWESTERLY CORNER ALONG UTAH AVENUE ON SURVEY NUMBER C-1302-M WAS COMPUTED FROM THE BEARING FROM THE NORTHEASTERLY CORNER OF BLOCK 5 WEST THAT WAS PREVIOUSLY COMPUTED AND THE DISTANCE AS LISTED IN SURVEY NUMBER C-1302-M.

THE NORTHWESTERLY ANGLE POINT CORNER ON SURVEY NUMBER C-1302-M WAS COMPUTED ON A BEARING FROM THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "TOMKINS SURVEYING" MARKING THE SOUTHWESTERLY CORNER OF SURVEY NUMBER C-1302-M AND THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "TOMKINS SURVEYING" MARKING THE NORTHWESTERLY CORNER OF SURVEY NUMBER C-1302-M ALONG WITH THE DISTANCE AS CALLED FOR IN SURVEY NO. C-1302-M

THE NORTHEAST CORNER OF LOT 2 WAS COMPUTED FROM A BEARING-BEARING INTERSECTION FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "TOMKINS SURVEYING" MARKING THE SOUTHWESTERLY CORNER OF SURVEY NUMBER C-1302-M AND THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "TOMKINS SURVEYING" MARKING THE NORTHWESTERLY CORNER OF SURVEY NUMBER C-1302-M WITH THE NORTH LINE OF BLOCK 5 WEST.

THE SOUTHEAST CORNER OF LOT 2 WAS COMPUTED FROM A BEARING-BEARING INTERSECTION FROM THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "TOMKINS SURVEYING" MARKING THE SOUTHWESTERLY CORNER OF SURVEY NUMBER C-1302-M AND THE FOUND 5/8" IRON ROD WITH A YELLOW PLASTIC CAP STAMPED "TOMKINS SURVEYING" MARKING THE NORTHWESTERLY CORNER OF SURVEY NUMBER C-1302-M WITH THE SOUTH LINE OF BLOCK 5 WEST.

THE NORTH LINE OF THAT PROPERTY AS DESCRIBED ON DOCUMENT NUMBER M-2000-1625 WAS PROPORTIONED IN FROM THE FOUND AND COMPUTED MONUMENTS WITH THE RECORD DIMENSIONS AS LISTED IN TAMBLYNS 1935 PLAT OF SECTION 25.

THE BASIS OF BEARING ON THIS PROJECT ARE THE FOUND 5/8" IRON ROD AT THE INTERSECTIONS OF FIRST STREET WEST WITH CALIFORNIA AVENUE AND THE FOUND RAIL ROAD SPIKE AT THE INTERSECTIONS OF SECOND STREET WEST WITH CALIFORNIA AVENUE AND IS BASED UPON SURVEY NUMBER C-1302-M.

THIS SURVEY WAS ACCOMPLISHED UTILIZING 2 TRIMBLE R-10 GNSS RECEIVERS. AN AUTONOMOUS POSITION WAS GENERATED ON THE BASE UNIT AND THE TWO PREVIOUSLY MENTIONED FOUND MONUMENTS WERE SUBSEQUENTLY USED FOR A SITE CALIBRATION FOR THE SYSTEM, EACH CORNER WAS THEN LOCATED OR SET ON A 15 SECOND EPOCH WITH A FIXED SOLUTION.
