SURVEYOR'S NARRATIVE

THIS SURVEY WAS UNDERTAKEN IN APRIL OF 2016 AT THE REQUEST OF DOUG C. AND GRACE M. SANDLIN. THE PURPOSE OF THE SURVEY IS TO REPLAT LOTS 1, 2, 3, 4 & 5 AND LOTS 11 AND 12 OF BLOCK 38, TOWN, NOW CITY OF IRRIGON, THEREBY ELIMINATING THE ORIGINAL BOUNDARIES OF PLAT. THE PARENT LOTS ARE DESCRIBED IN MORROW COUNTY DEED RECORDS LOTS 1-4 DOCUMENT NUMBER M-50347, EAST 1/2 OF LOT 5 DOCUMENT NUMBER 2009-24723, WEST 1/2 OF LOT 5 DOCUMENT NUMBER 2012-30036, LOTS 11 AND 12 DOCUMENT 2016-37908.

THE EXTERIOR BOUNDS OF THE PROPERTY WERE CALCULATED AND OR FOUND AS FOLLOWS:

I HELD THE FOUND MONUMENTS RECOVERED IN THE FIELD.

THE SOUTHEAST CORNER OF BLOCK 38 WAS COMPUTED ON A BEARING-BEARING INTERSECTION FROM THE FOUND SOUTHWEST CORNER OF BLOCK 38 AND THE FOUND NORTHEAST CORNER OF LOT 1, BLOCK 38. THE BEARINGS USED ARE FROM THE FOUND MONUMENT MARKING THE NORTHWEST CORNER OF LOT 10, BLOCK 38 AND THE FOUND MONUMENT MARKING THE NORTHEAST CORNER OF LOT 1, BLOCK 38 ALONG WITH THE FOUND MONUMENT MARKING THE NORTHEAST CORNER OF LOT 1. BLOCK 38 AND THE FOUND MONUMENT MARKING THE SOUTHEAST CORNER OF PARCEL 2 OF LAND PARTITION PLAT 2006-15.

THE ORIGINAL LOTS 1-10 WERE PROPORTIONED IN BASED ON THE FOUND MONUMENTS MARKING THE NORTHWEST CORNER OF LOT 10, BLOCK 38, THE FOUND MONUMENT MARKING THE SOUTHWEST CORNER OF LOT 10, BLOCK 38, THE FOUND MONUMENT MARKING THE NORTHEAST CORNER OF LOT 1. 38, THE FOUND MONUMENT MARKING THE NORTHEAST CORNER OF LOT 1, BLOCK 38 AND THE PREVIOUSLY COMPUTED LOCATION FOR THE SOUTHEAST CORNER OF LOT 10, BLOCK 38.

THE CENTERLINE OF LOT 5 WAS COMPUTED FROM THE PREVIOUSLY MENTIONED PROPORTIONED LOCATIONS FOR LOTS 1-10, BLOCK 38.

THE NORTH LINE OF LOT 12, BLOCK 38 WAS PROPORTIONED IN FROM THE FOUND MONUMENTS MARKING THE CORNERS TO THE NORTHEAST CORNER OF LOT 14, BLOCK 38, THE NORTHWEST CORNER OF LOT 14, BLOCK 38, THE SOUTHWEST CORNER OF LOT 11, BLOCK 38 AND THE SOUTHEAST CORNER OF LOT 11, BLOCK 38.

THE CORNERS THAT WERE PREVIOUSLY SET IN WINTER HAWK REPLAT FOR CARNAHAN APPEAR TO HAVE BEEN DISTURBED DUE TO FENCE

IT IS BELIEVED THAT LS 951 DID NOT FIND AND HOLD THE MONUMENTS MARKING THE SOUTHERLY CORNERES OF LOT 11 FOR ISOM REPLAT AND WINTER HAWK REPLAT WAS BASED UPON THE DATA ON ISOM REPLAT. THIS REPLAT WAS BASED UPON WINTER HAWK REPLAT AND THE FOUND MONUMENTS THAT WERE FOUND AND HELD.

THE BASIS OF BEARING OF THIS SURVEY ARE THE FOUND MONUMENTS AT THE NORTHEAST CORNER OF LOT 23 BLOCK 38 AND THE SOUTHEAST CORNER OF LOT 15 BLOCK 38 AND IS BASED ON WINTER HAWK REPLAT.

THIS SURVEY WAS ACCOMPLISHED UTILIZING 2 TRIMBLE R-10 GNSS RECEIVERS. AN AUTONOMOUS POSITION WAS GENERATED ON THE BASE UNIT AND THE TWO PREVIOUSLY MENTIONED FOUND MONUMENTS WERE SUBSEQUENTLY USED FOR A SITE CALIBRATION FOR THE SYSTEM, EACH CORNER WAS THEN LOCATED OR SET ON A 15 SECOND EPOCH WITH A FIXED SOLUTION.


