

THIS PROJECT WAS PERFORMED AT THE REQUEST OF MICHELLE AND JOSIAH MARTIN. THE PURPOSE OF THIS PROJECT WAS TO LOCATE CERTAIN MONUMENTS SHOWN HEREON AND TO MAP THE PROPOSED PROPERTY LINE ADJUSTMENT BETWEEN TWO TRACTS OF LAND OWNED BY MS. MARTIN, AS SHOWN. THE SUBJECT PROPERTY IS DESCRIBED IN MORROW COUNTY DEED INSTRUMENT NO. 2014-34826. THE DEED DESCRIBES TWO SEPARATE TRACTS OF LAND. THE FIRST BEING A TRACT SITUATED IN THE SE1/4 SECTION 35 AND THE SW1/4 SECTION 36, T.5S., R.25E., W.M.; SECTION 1, T.6S., R.25E., W.M. AND ALSO IN SECTION 6, T.6S., R.26E., W.M. THE FIRST TRACT IS ALSO KNOWN AS THE McDANIEL TRACT WHICH WAS CREATED IN 2004 BY PARTITION LP-S-339-04.

THE SECOND TRACT IS SITUATED IN THE SE1/4 SECTION 34 AND IN THE SW1/4 SECTION 35, T.5S., R.25E., W.M. THIS PROPERTY LINE ADJUSTMENT WAS APPROVED BY THE MORROW COUNTY PLANNING DEPARTMENT UNDER DOCUMENT NO. PLA-S-186-16.

AS MENTIONED ABOVE, THE McDANIEL TRACT WAS CREATED IN 2004 BY PARTITION LP-S-339-04. AS WAS ALLOWED IN MORROW COUNTY AT THAT TIME, THERE WAS NOT A PLAT PREPARED FOR THAT PARTITION PROCESS. RATHER, THE PARTITION PROCESS WAS COMPLETED BY THE RECORDING OF DEEDS. THE RESULT OF THIS BEING THAT INFORMATION CONCERNING LP-S-339-04 IS ONLY AVAILABLE THROUGH THE MORROW COUNTY PLANNING DEPARTMENT. THIS MAP SHOWS ONLY THE PORTION OF SAID McDANIEL TRACT THAT IS DIRECTLY AFFECTED BY THIS PROPERTY LINE ADJUSTMENT.

THE FOUND CORNER MONUMENTS SHOWN HEREON WERE PERPETUATED BY DENNIS GAYLORD, PLS IN 2003 AS PART OF A CORNER REMONUMENTATION PROJECT. I CALCULATED THE POSITION OF THE CLOSING TOWNSHIP CORNER BETWEEN T.6S. R.25E., AND T.6S., R.26E. ON A LATITUDINAL CURVE BETWEEN FOUND MONUMENTS ON THE STANDARD PARALLEL AND WITH REFERENCE TO THE 2009 BLM MANUAL OF SURVEYING INSTRUCTIONS.

ALL UNSURVEYED SECTION AND SECTION SUBDIVISION LINES HAVE BEEN PROTRACTED FOR GENERAL INFORMATION ONLY. RANKIN ROAD AND HIGHWAY 207 ARE MAPPED FROM RECORD INFORMATION. ALL UNSURVEYED BEARINGS AND DISTANCES ARE EITHER DEED RECORD OR APPROXIMATE. THE UNSURVEYED LINES AND AREAS SHOWN HEREON MAY CHANGE UPON THE EXECUTION OF A COMPLETE SURVEY. THE ADJUSTED PROPERTY LINE IS ALONG THE CENTERLINE OF AN EXISTING ROAD WAY AND HAS BEEN SURVEYED.

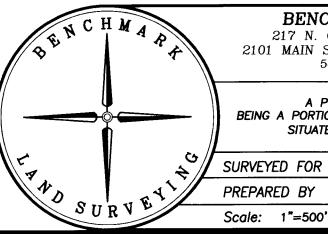
