## **NARRATIVE**

THIS SURVEY WAS PERFORMED AT THE REQUEST OF MICHELLE MARTIN. THE PURPOSE OF THIS SURVEY WAS TO PARTITION PROPERTY OF THE MICHELLE MARTIN TRUST AS DESCRIBED IN MORROW COUNTY DEED INSTRUMENT NO'S 2014-34826, 2017-40990 AND 2017-41014 INTO THREE PARCELS. THIS PARTITION IS LARGELY UNSURVEYED. BUT I DID LOCATE SEVERAL INTEGRAL CONTROLLING SECTION AND QUARTER SECTION CORNERS. I ALSO LOCATED BY SURVEY THE CENTERLINES OF STATE HIGHWAY 207. RANKIN ROAD AND THE PRIVATE ACCESS EASEMENT THAT ACTS AS A PORTION OF THE WEST LINE OF PARCEL 2 AND ALSO AS THE DIVISION LINE BETWEEN PARCELS 1 AND 2.

THIS IS A PARTITION OF A PORTION OF THE MCDANIEL TRACT WHICH WAS CREATED IN 2004 BY PARTITION NO. LP-S-339-04. AS WAS ALLOWED IN MORROW COUNTY AT THAT TIME, NO PLAT WAS PREPARED FOR THAT PARTITION PROCESS. THIS MAP SHOWS ONLY THE PORTION OF SAID MCDANIEL TRACT REMAINING AFTER A PROPERTY LINE ADJUSTMENT AS SHOWN ON MORROW COUNTY SURVEY NO. 1782 AND AS EVIDENCED AND DESCRIBED IN MORROW COUNTY DEED INSTRUMENT NO. 2017-40990. DURING THE SURVEY AND DEED RESEARCH FOR THIS PROJECT, I FOUND THAT A PORTION OF THE NE1/4 OF SECTION 7, T.6S., R.26E., W.M. LYING WESTERLY OF HIGHWAY 207 WAS INADVERTENTLY LEFT OFF THE ORIGINAL DEED DESCRIPTION FOR THE MCDANIEL TRACT IN 2004. I CONFIRMED THAT THIS SMALL TRACT WAS ERRONEOUSLY OMITTED BY CONTACTING MR. D. RAHN HOSTETTER WHO STILL HELD TITLE TO THE TRACT. MR. HOSTETTER HAS SINCE CORRECTED THE OMISSION BY RECORDING DEED NO. 2017-41014 IN THE OFFICE OF THE MORROW COUNTY CLERK.

THE SOUTH LINE OF T.5S., R.25E., WAS ORIGINALLY SURVEYED BY EVERETT A. THATCHER, U.S. DEPUTY SURVEYOR FOR THE GENERAL LAND OFFICE (GLO) UNDER CONTRACT NO. 325 DATED AUGUST 13, 1879. THE RANGE LINE BETWEEN T.6S., R.25E. AND R.26E. WAS ORIGINALLY SURVEYED BY EDWARD W. SANDERSON, U.S. DEPUTY SURVEYOR UNDER CONTRACT NO. 368 DATED APRIL 21, 1881. MR. SANDERSON ALSO SUBDIVIDED T.6S., R.26E. UNDER THE SAME CONTRACT.

IN 2003, DENNIS GAYLORD, PLS REMONUMENTED SEVERAL CORNERS IN THE VICINITY OF THIS PROJECT. ALL OF THE CORNERS FOUND DURING THIS SURVEY THAT WERE REMONUMENTED BY MR. GAYLORD UTILIZED ORIGINAL GLO EVIDENCE. I ACCEPT ALL THE FOUND MONUMENTS SET BY MR. GAYLORD SHOWN HEREON.

I PREPARED COUNTY SURVEY NO. 1782 IN 2016 WHICH SHOWS A PROPERTY LINE ADJUSTMENT IN SECTIONS 35 AND 36, T.5S.,R.25E. DURING THAT SURVEY I FOUND AND ACCEPTED SEVERAL OF THE CORNER MONUMENTS REMONUMENTED BY DENNIS GAYLORD.

IN 2017, IN PREPARATION FOR THIS PARTITION PLAT I REMONUMENTED ORIGINAL GLO EVIDENCE AT THE COMMON SECTION CORNER TO SECTIONS 6 AND 7, T.6S., R.26E. AND ALSO AT THE COMMON SECTION CORNER TO SECTIONS 1 AND 12. T.6S., R.25E. I FILED CORNER RESTORATION RECORDS IN THE OFFICE OF THE MORROW COUNTY SURVEYOR FOR THESE REMONUMENTED CORNERS.


RONALD MCKINNIS PREFORMED MORROW COUNTY SURVEY NO. 1701 IN 2007. MR. MCKINNIS'S SURVEY WAS A DEPENDENT RESURVEY AND SUBDIVISION OF SECTIONS 7 AND 18, T.6S., R.26E., W.M. AN ANALYSIS OF SURVEY 1701 INDICATES THAT MR. MCKINNIS USED UNCONVENTIONAL METHODS TO CONDUCT HIS SURVEY, MANY OF WHICH WERE NOT IN ACCORDANCE WITH THE BLM MANUAL OF SURVEYING INSTRUCTIONS. OF MOST IMPORTANCE TO THIS SURVEY ARE DECISIONS MCKINNIS MADE AFFECTING THE NW1/4 OF SAID SECTION 7. HE RELIED ON "PLACARDS" SET BY EMPLOYEES OF KINZUA TIMBER COMPANY AT APPROXIMATE LOCATIONS OF THE S1/4 CORNER AND THE C-N1/16 CORNER IN ORDER TO ESTABLISH THE POSITION FOR THE C1/4 CORNER. HE ALSO ACCEPTS A KINZUA "PLACARD" AND AN UNRECORDED MOUND OF STONE OVER 50 FEET SOUTH OF THE CALCULATED POSITION FOR THE N1/16 CORNER ON THE WEST LINE OF SECTION 7. MCKINNIS ALSO FAILED TO LOCATE THE BRASS CAP MONUMENT SET BY DENNIS GAYLORD AT THE N1/4 CORNER OF SECTION 7 WHICH IS OVER 100 FEET WEST OF MCKINNIS'S CALCULATED POSITION, WHICH WAS BASED ON KINZUA "PLACARDS". FOR THE REASONS STATED HEREIN, I DO NOT ACCEPT THE SUBDIVISION OF SECTION 7 AS SHOWN ON COUNTY SURVEY NO. 1701.

AS STATED ABOVE, THIS PARTITION PLAT IS LARGELY UNSURVEYED. THEREFORE, DUE TO THE EXCESSIVE EXPENSE THAT WOULD BE INCURRED BY MRS. MARTIN IN ORDER TO CONDUCT A COMPREHENSIVE RESURVEY AND SUBDIVISION OF SECTION 7, I HAVE USED THE FOUND MONUMENTS SHOWN HEREON AND RECORD LOCATIONS OF SEVERAL OF MR. MCKINNIS'S CORNERS TO PARTIALLY SUBDIVIDE SAID SECTION 7 IN THE FOLLOWING MANNER:

I UTILIZE THE RECORD LOCATIONS OF THE EAST, WEST AND SOUTH 1/4 CORNERS AS SHOWN ON SURVEY NO. 1701. I ALSO USE THE LOCATIONS OF THE FOUND MONUMENTS AT THE NORTHWEST CORNER AND N1/4 CORNER OF SAID SECTION. I CALCULATE THE C1/4 AT THE INTERSECTION OF OPPOSITE 1/4 CORNERS OF SAID SECTION 7. THE N1/16 CORNER ON THE WEST LINE OF SAID SECTION AND THE C-N1/16 CORNER ARE CALCULATED AT THE MID-POINT BETWEEN CONTROLLING CORNERS TO THE NORTH AND SOUTH OF EACH 1/16 CORNER, RESPECTIVELY. FROM THIS POINT THE NW1/4 OF SAID SECTION IS SUBDIVIDED USING THE GLO RECORDS AND WITH RESPECT TO THE 2009 BLM MANUAL OF SURVEYING INSTRUCTIONS.

THE DIVISION LINE BETWEEN PARCELS 1 AND 2 IS ALONG THE CENTERLINE OF AN EXISTING GRAVEL AND DIRT ROAD WHICH HAS BEEN LOCATED BY SURVEY. THE DIVISION LINE BETWEEN PARCELS 2 AND 3 WAS SURVEYED AND MONUMENTED AS PART OF THIS PARTITION PROCESS. I USED THE RECORD CENTERLINE ALIGNMENT OF STATE HIGHWAY 207 AS SHOWN ON OREGON STATE HIGHWAY DEPARTMENT MAP NO. 8B-6-7. THE EXISTING HIGHWAY CENTERLINE WAS SURVEYED AND COMPARED AND FOUND TO CORRELATE WELL WITH THE RECORD CENTERLINE AS SHOWN ON SAID MAP NO. 8B-6-7.

ALL UNSURVEYED SECTION AND SECTION SUBDIVISION LINES HAVE BEEN PROTRACTED FOR GENERAL INFORMATION ONLY. ALL UNSURVEYED BEARINGS AND DISTANCES ARE EITHER RECORD OR APPROXIMATE. THE UNSURVEYED LINES AND AREAS SHOWN HEREON MAY CHANGE UPON THE EXECUTION OF A COMPLETE SURVEY.
