

SURVEYOR'S CERTIFICATE:

I, DAVID P. BAALMAN, A REGISTERED LAND SURVEYOR, HEREBY CERTIFY THAT THE PARTITION PLAT AS SHOWN IS BASED UPON ACTUAL FIELD SURVEY OF THE LAND DESCRIBED AND THAT ALL ANGLES, DISTANCES, AND COURSES FOR PARCELS 2 AND 3 ARE HEREON CORRECTLY SHOWN AND THAT THE CORNERS FOR SAID PARCELS 2 AND 3 HAVE BEEN STAKED ON THE GROUND AS SHOWN ON THE MAP IN ACCORDANCE WITH ORS CHAPTER 92 AS REVISED AND WITH THE MORROW COUNTY SUBDIVISION ORDINANCE. SURVEYOR'S NARRATIVE:

THE PURPOSE OF THIS PARTITION PLAT IS TO CREATE TWO NEW PARCELS FROM TAX LOT 1501 FOR TRANSFER TO NEIGHBORING PROPERTY OWNER TO CONFORM TO EXISTING OCCUPATION LINES.

MONUMENTS WERE SEARCHED FOR AT ALL EXTERIOR CORNERS OF THE SUBJECT PARCELS. FOUND MONUMENTS SHOWN HEREON WERE HELD FOR THE TRUE BOUNDARY OF THE SUBJECT PARCELS. THESE MONUMENTS ORIGINATE FROM RECORDED SURVEYS. MISSING CORNER POSITIONS ALONG THE EXTERIOR BOUNDARY OF THE SUBJECT PROPERTY WERE EITHER COMPUTED BY THE RECORD LEGAL DESCRIPTIONS OR SURVEYS OF RECORD AS STATED IN THE SHEET NOTES WITH LEADER CALLOUTS TO THE CORNERS THEMSELVES.

LEGAL DESCRIPTIONS FOR THE EXISTING PARCELS REFERENCE CURVE COURSES WITHOUT SPECIFYING THEIR TANGENCY OR RELATION TO PREVIOUS COURSES. WHEN HELD AS TANGENTIAL CURVES, THESE DESCRIPTIONS DO NOT MATHEMATICALLY "CLOSE". ALL CURVES ARE ASSUMED NON-TANGENT UNLESS OTHERWISE NOTED. REFERENCE SURVEY RECORDED IN FOLDER 1858 UNDER 2019-1858C, MORROW COUNTY SURVEY RECORDS.

AT THE NORTHEAST CORNER OF SECTION 27, SOUTHEAST CORNER OF SECTION 27, AND SOUTHEAST CORNER OF SECTION 34, WE FIND REMAINS OF OLD T-POSTS, WHICH ARE BELIEVED TO BE EITHER OLD WITNESS POSTS OR OLD FENCES. NO EVIDENCE OF THE ACTUAL CORNER MONUMENTS WAS FOUND.
