THE PURPOSE OF THIS SURVEY IS TO ESTABLISH THE BOUNDARIES OF LOTS 9-13, "GLENAIRE ESTATES", EXCEPTING THEREFROM THAT PORTION LYING WITHIN THE PLAT OF "RIVER RIDGE ESTATES", AND LOTS 10-28 " MOORE RANCH ESTATES" (TOGETHER WITH THAT PORTION OF SW BRANDING IRON ROAD, SW LARIAT LANE, AND SW RAWHIDE LANE THAT INURED THERETO, AFFECTING ANY OF THE ABOVE DESCRIBED LOTS, UPON VACATION ORDINANCE NO. 8-2002, RECORDED 4-8-2002 AS MICROFILM NO. 2002-3904, MORROW COUNTY MICROFILM RECORDS), AND TO ESTABLISH AND MONUMENT THE BOUNDARY OF THE LAND DESCRIBED IN DOCUMENT NO. 2020-47153, MORROW COUNTY DEED RECORDS, FOR A PROPOSED SUBDIVISION.

THE BASIS OF BEARINGS IS THE OREGON STATE PLANE COORDINATE SYSTEM, NORTH ZONE, NAD 83 (1991). ALL DISTANCES SHOWN ARE GROUND DISTANCES.

MONUMENTS 1-4 WERE HELD FOR THE CORNERS OF THE SOUTHEAST I/4 OF SECTION 17.

THE MOST EASTERLY BOUNDARY LINE WAS ESTABLISHED BY A LINE BETWEEN THE MIDPOINTS OF THE NORTH AND SOUTH QUARTER SECTION LINES. THE MOST WESTERLY EAST BOUNDARY LINE WAS ESTABLISHED BY HOLDING MONUMENT 9 AND THE MONUMENTS FOUND ON THE EAST LINE OF LOT 10, MOORE RANCH ESTATES.

THE NORTH LINE OF LOT 16, MOORE RANCH ESTATES WAS ESTABLISHED BY HOLDING THE MONUMENT FOUND AT THE NORTHWEST LOT CORNER AND EXTENDING THE LINE EASTERLY TO THE MIDPOINT OF THE EAST LINE OF THE SOUTHEAST QUARTER OF SECTION 17 PER R1.

THE MOST NORTHERLY BOUNDARY LINE WAS ESTABLISHED ALONG THE SOUTH LINE OF THE PLAT OF RIVER RIDGE ESTATES BY HOLDING MONUMENTS 5-9.

THE SOUTH BOUNDARY LINE WAS ESTABLISHED ON THE NORTH RIGHT OF WAY LINE OF S.W. KUNZE LANE BY OFFSETTING THE SOUTH QUARTER SECTION LINE 30.00 FEET NORTH PER R5.

THE WEST BOUNDARY LINE WAS ESTABLISHED ON THE WEST LINE OF THE QUARTER SECTION BY HOLDING MONUMENTS 1, 4, AND 5 AS WELL AS THE MONUMENT FOUND AT THE SOUTHWEST CORNER OF LOT 13, MOORE RANCH ESTATES.

THE SOUTH LINE OF LOT 15 WAS ESTABLISHED BY HOLDING THE MONUMENTS FOUND ON THE SOUTH LINE OF LOTS 13 AND 14, AND EXTENDING THE LINE EASTERLY. THE EAST LINE OF LOT 15 WAS ESTABLISHED BY HOLDING THE MONUMENTS FOUND ON THE EAST LINE OF LOT 10 AND ON THE EAST LINE OF LOT 15 AND EXTENDING THE LINE SOUTHERLY. THE SOUTHEAST CORNER OF LOT 15 WAS ESTABLISHED AT THE INTERSECTION POINT OF THE SOUTH AND EAST LOT LINES.


