SUBJECT PROPERTY WAS PREVIOUSLY SURVEYED AS PARTITION PLAT NO. 2011–19 AND PARTITION PLAT NO. 2012–06 BY RONALD V. McKINNIS, LS 2431. THE INTENT OF THIS SURVEY IS TO RE—PLAT PARCEL 3 OF PARTITION PLAT NO. 2011–19 AND PARCELS 1 AND 2 OF PARTITION PLAT NO. 2019–16. SEARCH IN THE FIELD RECOVERED ALL THE MONUMENTS PREVIOUSLY SET DURING THE ABOVE MENTIONED PARTITIONS, EXCEPT THE CORNER LOCATIONS 1 AND 2. I HELD THE RECOVERED MONUMENTS FOR THE EXTERIOR BOUNDARY OF THIS PLAT. THE SOUTH LINE OF SAID PARCEL 3 AND THE LINE BETWEEN SAID PARCELS 1 AND 2 ARE TO BE ABANDONED. THE REMAINING PARTITION LINES ARE FREE LINES AS DESIRED BY THE CLIENT. THIS SURVEY WAS PERFORMED USING A TRIMBLE R10 GPS SYSTEM IN RTK MODE.
