

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO RESOLVE THE EXISTING RIGHT OF WAY FOR PORTION OF HEPPNER HIGHWAY (OR74) FROM THE INTERSECTION WITH "F" STREET SOUTHEASTERLY TO THE INTERSECTION WITH "A" STREET IN THE CITY OF LEXINGTON, OREGON.

THIS SURVEY PERPETUATES THOSE SURVEY MONUMENTS WITHIN THE PROJECT LIMITS IN JEOPARDY OF BEING DESTROYED BY A FUTURE CURB RAMP CONSTRUCTION PROJECT. THIS SURVEY MEETS THE REQUIREMENTS FOR A RECOVERY SURVEY AS OUTLINED IN THE OREGON REVISED STATUTES, SECTION 209.155. THIS SURVEY WAS PERFORMED IN INTERNATIONAL FEET UNITS. THIS SURVEY WAS PERFORMED BETWEEN THE MONTHS OF MARCH 2020 AND APRIL 2021. THE SURVEY EQUIPMENT USED CONSISTED OF LEICA GS-14 RECEIVERS, LEICA TS16 TOTAL STATIONS, AND LEICA CS15 AND CS20 SURVEY CONTROLLERS.

THE PORTION OF HEPPNER HIGHWAY (MAIN STREET) FROM THE "A" STREET TO "F" STREET WAS DEDICATED PER THE ORIGINAL TOWN PLAT OF LEXINGTON FILED JUNE 19, 1885 AT A WIDTH OF 90.83 FEET. IN 1973, DONALD STAEBLER MONUMENTED THE CENTER LINE OF "C" STREET BASED UPON THE LOCATION OF SIDEWALKS, FENCES AND BUILDINGS. IN 1980, KRUMBEIN ENGINEERING COMPANY MONUMENTED THE CENTER LINES OF "F" STREET AND "C" STREETS FROM MAIN STREET TO WEST STREET FOR THE CITY OF LEXINGTON. THERE IS AN ERROR IN RECORD DISTANCE OF OVER 9 FEET BETWEEN "A" STREET AND "F" STREET DESCRIBED ON COUNTY SURVEY 2016-1766C BY STEPHEN K. HADDOCK, IF ALL OF THIS ERROR IS PLACED IN THE BLOCKS BETWEEN "A" STREET AND "B" STREET AS STEPHEN HADDOCK SUGGESTS, IT CREATES A SIGNIFICANT BUILDING ENCROACHMENT AT THE SOUTHWEST AND SOUTHEAST CORNERS OF "C" STREET, THEREFORE THE CENTER LINE MONUMENTS SET BY KRUMBEIN ENGINEERING COMPANY ON "C" STREET WERE ACCEPTED TO DEFINE THE CENTER LINE INTERSECTIONS OF "C" STREET WITH MAIN STREET, ARCADE STREET, AND EAST STREET. BY ACCEPTING THE MONUMENTS ON "C" STREET, APPROXIMATELY HALF OF THE ERROR IS DISTRIBUTED BETWEEN "F" AND "C" STREETS AND THE OTHER HALF IS PLACED BETWEEN "C" AND "A" STREET. AFTER REVIEW OF SURVEYS AND OCCUPATION LINES, I PLACED THE 4.72 FEET OF ERROR WESTERLY OF "C" STREET IN THE BLOCKS BETWEEN "C" STREET, AND THE 4.82' OF ERROR EASTERLY OF "C" STREET IN THE BLOCKS BETWEEN "A" AND "B" STREET.

TO RESOLVE THE CENTER LINE OF MAIN STREET, THE CENTER LINE MONUMENT AT THE INTERSECTION OF MAIN STREET WITH "F" STREET WAS HELD, THE CENTER LINE MONUMENT AT THE INTERSECTION OF MAIN WITH "C" STREET WAS HELD, AND RECORD DISTANCE OF 39.417' FROM THE MONUMENT FOUND AT POINT 1014 WAS HELD. STATIONING OF 25+00.00 P.O.T. WAS ESTABLISHED PER THIS SURVEY AT THE MONUMENT FOUND AT THE INTERSECTION OF "F" STREET WITH MAIN STREET. RECORD WIDTHS OF THE SIDE STREETS WERE DETERMINED PER THE PLAT OF LEXINGTON.

PRIMARY CONTROL WAS BROUGHT INTO THE PROJECT USING THE OREGON REAL TIME GNSS NETWORK (ORGN) TO ESTABLISH HORIZONTAL POSITIONS ON GPS CONTROL STATIONS I THROUGH 4, AND POINT 1021 BY INCORPORATING THE AVERAGE OF TWO SEPARATE OBSERVATIONS UNDER DIFFERENT SATELLITE CONSTELLATIONS. THE HORIZONTAL DATUM USED FOR THIS PROJECT IS NAD 83(2011) EPOCH 2010, OREGON COORDINATE REFERENCE SYSTEM (OCRS), NORTH CENTRAL ZONE. THE NORTH CENTRAL ZONE PROJECTION PARAMETERS ARE PUBLISHED IN OREGON ADMINISTRATIVE RULES (OAR) 734-005-015. BASIS OF BEARINGS: MEASURED BEARINGS ARE GRID PER THE PROJECT DATUM.

VERTICAL CONTROL WAS ESTABLISHED BY HOLDING THE PUBLISHED ELEVATION OF 1471.42' FOR NATIONAL GEODETIC SURVEY (NGS) BENCHMARK X86 (PID RB0855), AND RUNNING A CLOSED LEVEL CIRCUIT THROUGH THE CONTROL POINTS SHOWN ON THIS SURVEY. ELEVATIONS ARE ON THE NAVD88 VERTICAL DATUM.
