THE SUBJECT PROPERTY BEING PARTITIONED IS DESCRIBED IN THAT BARGAIN AND SALE DEED RECORDED NOVEMBER 10, 2011 AS INSTRUMENT NO. 2011-29130, OFFICIAL RECORDS OF MORROW COUNTY, OREGON, AND IS COMPRISED OF SECTION 24 T4N, R25E, W.M. THE SUBJECT PROPERTY BOUNDARY WAS RETRACED BY PARAMETRIX IN JANUARY OF 2021. THE RESULTS ARE SHOWN ON THIS PLAT WITH COMPARISON TO THE SURVEYS OF RECORD AS FOUND WITHIN THE MORROW COUNTY SURVEY RECORDS. BOMBING RANGE ROAD, A PUBLIC ROAD RIGHT-OF-WAY, IS INCLUDED WITHIN THE DEED DESCRIPTION FOR THE SUBJECT PROPERTIES.

RECOVERED MONUMENTS MARKING THE CORNERS AND QUARTER CORNERS OF SAID SECTION 24 WERE HELD AND UTILIZED TO CALCULATE POSITIONS FOR THE REMAINING CORNERS SHOWN HEREON.

THE PURPOSE OF THIS SURVEY IS TO PARTITION THE REFERENCED LISTED PARCEL, TAX LOT 4N25 1700, INTO TWO PARCELS. THE NEW LINE BETWEEN THE TWO PARCELS WAS MONUMENTED AS PART OF THIS PLAT.
