

THIS PROPERTY LINE ADJUSTMENT SURVEY HAS BEEN PREPARED AT THE REQUEST OF MARK AND PAM WUNDERLICH. THE PURPOSE OF THIS SURVEY IS TO COMPLETE THE SURVEY REQUIREMENTS OF APPROVED MORROW COUNTY PLANNING DEPARTMENT PROPERTY LINE ADJUSTMENT PLA-S-205-21, PER THE MORROW COUNTY SUBDIVISION ORDINANCE. THE PROPERTY IS BEING ADJUSTED AT THE DIRECTION OF MY CLIENT AS DEPICTED HEREON. THOSE PORTIONS OF REAL PROPERTY BEING CONVEYED ARE SHOWN WITH HATCHING. LEGAL DESCRIPTIONS FOR THE TRANSFER PARCELS AND RESULTANT TAX LOTS HAVE BEEN PREPARED BY SEPARATE DOCUMENT.

CONSISTENT WITH ORS CHAPTER 92, AND THE MORROW COUNTY SUBDIVISION ORDINANCE, THIS PROPERTY LINE ADJUSTMENT SURVEY IS "UNSURVEYED". THE PROPERTY BOUNDARIES WERE COMPUTED USING THE COMBINATION OF RECORD GLO DATA WITH THE LEGAL DESCRIPTIONS CONTAINED IN DOCUMENT NUMBER 2011-27863, MORROW COUNTY CLERK RECORDS. APPROXIMATE DIMENSIONS AND ACREAGE OF THE EXISTING AND ADJUSTED PARCELS ARE SHOWN HEREON. DIMENSIONS PER THE AFOREMENTIONED RECORD DEED ARE FOLLOWED BY THE ANNOTATION, "(D)". LEGAL DESCRIPTIONS FOR THE TRANSFER PARCELS AND RESULTANT PARCELS HAVE BEEN PREPARED BY SEPARATE DOCUMENT.

THIS SURVEY WAS PERFORMED USING TWO TOPCON HIPER LITE+ GNSS UNITS OPERATED USING BOTH STATIC AND RTK METHODS. THE BASIS OF BEARING IS THE SUBDIVISION OF TOWNSHIP 3 SOUTH, RANGE 28 EAST BY GEORGE WILLIAMS, CONTRACT NO. 176 DATED JULY 20TH 1872.
