

SURVEY NARRATIVE

THIS SURVEY HAS BEEN PREPARED AT THE REQUEST OF WILLIAM AND NEVA MAHON. THE PURPOSE IS TO ADJUST THE PROPERTY LINE BETWEEN LOTS 22 AND 23 OF LAKEVIEW HEIGHTS, CITY OF HEPPNER, OR. THE EASTERLY 10.00 FEET OF LOT 22 WILL BE CONVEYED TO LOT 23 AS DIRECTED BY MY CLIENT AND SHOWN HEREON. CONVEYANCE DOCUMENTS WILL BE RECORDED IN CONJUNCTION WITH THIS SURVEY.

ORIGINAL MONUMENTATION PER THE PLAT OF LAKEVIEW HEIGHTS WERE FOUND AND HELD AS SHOWN HEREON. THE NORTHEAST AND NORTHWEST CORNERS OF LOT 23 WERE NOT FOUND. THESE CORNERS WERE COMPUTED BY PROPORTIONATE MEASURE USING THE NORTHEAST CORNER OF LOT 24 AND NORTHWEST CORNER OF LOT 22. THE NORTHEAST CORNER OF LOT 23 COULD NOT BE SET AS AN EXISTING POWER VAULT OCCUPIES THE CORNER LOCATION. TWO 5-FOOT REFERENCE POINTS WERE ESTABLISHED AS SHOWN, 5 FEET DISTANT FROM THE COMPUTED LOT CORNER ON THE SOUTHERLY RIGHT-OF-WAY MARGIN OF FRANK GILLIAM DRIVE.

THIS SURVEY WAS PERFORMED USING TWO TOPCON HIPER LITE+ GNSS UNITS OPERATED IN RTK MODE. THE BASIS OF BEARINGS IS THE PLAT OF LAKEVIEW HEIGHTS AS ESTABLISHED BY MEASURE BETWEEN THE NORTHWEST CORNER OF LOT 22 AND THE NORTHEAST CORNER OF LOT 24. DISTANCES ARE GROUND, INTERNATIONAL FEET.
