

NARRATIVE:

THE PURPOSE OF THIS SURVEY IS TO LOCATE THE BOUNDARIES OF THE TAX LOTS LISTED IN THE "SURVEYED LEGAL DESCRIPTIONS" AND PERFORM A TOPOGRAPHIC SURVEY WITHIN PORTIONS OF TAX LOTS 5000, 5100, 5200, 7300 AND 7600 FOR USE IN DESIGN OF FUTURE SCHOOL DISTRICT

CONFLICTING EVIDENCE WAS FOUND REGARDING THE LOCATION OF THE PROPERTY BOUNDARIES FROM VARIOUS SURVEYS WHEN RESEARCHING THE SUBJECT PROPERTIES. MORROW COUNTY SURVEY C-1365-M PERFORMED BY WAGNER APPEARS TO HAVE ERRONEOUSLY SURVEYED THE LOCATION OF TAX LOT 7600 BY ASSUMING THE WESTERLY RIGHT-OF-WAY OF WILLOW STREET TO BE COINCIDENT WITH THE WEST LINE OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 9 AS STATED BY WELLS IN SURVEY 2014-1721-C. THE LEGAL DESCRIPTION FOR TAX LOT 7400 AS LISTED BY DEED 05014773, AND PARTIALLY SURVEYED BY EDWARDS IN SURVEY C-900-E, SHOWS THE WESTERLY RIGHT-OF-WAY OF SPRING STREET TO BE LOCATED 520 FEET EAST OF THE WEST LINE OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 9.

STEVE HADDOCK IN SURVEY 1499-C FOUND AND REMONUMENTED ORIGINAL EVIDENCE MARKING THE NORTHWEST CORNER OF BLOCK 1 OF THE ORIGINAL TOWN OF IONE AND SHOWS THAT THE SUBDIVISION BOUNDARY (THE WESTERLY R/W OF WILLOW STREET) AND THE 1/16TH LINE ARE NOT

I AGREE WITH THE DETERMINATION OF HADDOCK AND WELLS AND REJECT THE MONUMENTS SET BY WAGNER AND UTILIZE THOSE MONUMENTS SET BY WELLS IN SURVEYS 2014-1721-C AND 2013-28C TO CONTROL THE LOCATION FOR SPERRY'S SECOND ADDITION. FROM THESE MONUMENTS ! REESTABLISH THE BLOCKS FOR SPERRY'S THIRD AND FOURTH ADDITIONS. THE SOLUTION CREATED BY UTILIZING THE MONUMENTS FROM HADDOCK AND WELLS COINCIDES WITH IMPROVEMENTS ALONG PLATTED LINES FURTHER EAST OF THIS SURVEY.

TO ESTABLISH THE LOCATION OF IONE-GOOSEBERRY MARKET ROAD I UTILIZE THE MONUMENTS SET BY EDWARDS FROM SAID SURVEY C-900-E TO REBUILD THE SOUTHERLY RIGHT-OF-WAY MARGIN OF SAID ROAD. I THEN OFFSET THIS SOUTHERLY MARGIN 60.00 FEET NORTHERLY TO ESTABLISH THE NORTHERLY RIGHT-OF-WAY MARGIN THEREOF. EDWARDS SOLUTION FITS WELL WITH THE AS-BUILT LOCATION OF SAID ROAD. WHERE GOOSEBERRY ROAD INTERSECTS WITH SPRING STREET I ESTABLISH THE ROAD CENTERLINE ON A BEST FIT CURVE WHICH I OFFSET NORTHWESTERLY AND SOUTHEASTERLY TO ESTABLISH THE RIGHT-OF-WAY MARGINS FOR SAID CURVE. A LEGAL DESCRIPTION FOR THE RIGHT-OF-WAY FOR THIS STRETCH OF ROAD IS DESCRIBED IN DEED RECORDED IN BK. 33, PG. 313 FILED NOV. 14, 1919. THE CENTERLINE POSITION DESCRIBED IN SAID DEED GENERALLY FOLLOWS THE ASBUILT ALIGNMENT OF GOOSEBERRY ROAD BUT DOES NOT FIT WITH CURRENT SURVEY MONUMENTATION AND ROAD LOCATION. THEREFORE I ELECT TO REBUILD THE RIGHT-OF-WAY USING EDWARDS RECORD AS STATED ABOVE.

THE STATUS OF THE RIGHT-OF-WAY SHOWN FOR SPRING STREET LYING SOUTHERLY OF THE INTERSECTION WITH GOOSEBERRY ROAD IS UNKNOWN. THE PLATS OF SPERRY'S 3RD AND FOURTH ADDITIONS DO NOT INCLUDE THAT AREA AS DEDICATED AND THE DEED DESCRIPTION IN THE RIGHT-OF-WAY DEDICATION TERMINATES AT THE INTERSECTION OF THIRD STREET AND CHERRY STREET. TITLE TO THAT SECTION OF "ROADWAY" MIGHT BE HELD BY THE ORIGINAL SUBDIVIDER BUT THE SCHOOL DISTRICT HAS OCCUPIED AND MAINTAINED THAT SECTION OF PROPERTY FOR MANY

THE LEGAL DESCRIPTION FOR TAX LOT 7300 INCLUDES PORTIONS OF THIRD STREET AND BIRCH STREET BUT NO ORDINANCE STATING THEM TO BE VACATED WAS FOUND. IN 2005 A DEED WAS EXECUTED BETWEEN MORROW COUNTY SCHOOL DISTRICT AND IONE SCHOOL DISTRICT CONVEYING A PORTION OF THE RIGHT-OF-WAY FOR BIRCH STREET WEST OF BLOCK 9, DENOTED HEREON AS

SIMILARLY AN ORDINANCE WAS NOT FOUND VACATING THE EAST-WEST ALLEY RUNNING THROUGH THE CENTER OF BLOCK 2, SPERRY'S THIRD ADDITION. A DEED FROM THE CITY OF IONE TO SCHOOL DISTRICT NO. 35 OF MORROW COUNTY WAS EXECUTED FEB. 13, 1947 IN BK. 50, PG. 21 CONVEYING ALL OF BLOCK 2 OF SPERRY'S 3RD ADDITION FOR THE PURPOSES OF A SCHOOL GROUND AND A PARK, AND THE GRANTOR RESERVED THE RIGHT TO USE THE PROPERTY AS A

A POTENTIAL ENCROACHMENT EXISTS IN THE SOUTHEAST CORNER OF TAX LOT 7600 BETWEEN TAX LOT 7600 AND THE NEIGHBORING PROPERTY TAX LOT 9200. IT APPEARS THAT WHEN THE LEGAL DESCRIPTIONS WERE WRITTEN FOR THESE PROPERTIES THE PRESUMED ASSUMPTION WAS THAT ALL RECORD DATA WAS PERFECT. THE DESCRIPTION FOR TAX LOT 9200 COMMENCES AT THE SOUTHEAST CORNER OF BLOCK 3 SPERRY'S FOURTH ADDITION AND HEADS WEST AND THE DESCRIPTION FOR TAX LOT 7600 COMMENCES AT THE SOUTHWEST CORNER OF BLOCK 2 SPERRY'S FOURTH ADDITION AND HEADS EAST. GIVEN THE CURRENT SURVEY MONUMENTATION, AN OVERLAP IS CREATED BETWEEN THE TWO DESCRIPTIONS. THE INTENT HOWEVER, IS TO FORM A HARMONIOUS BOUNDARY. TAX LOT 9200 WAS PARTIALLY SURVEYED BY KRUMBEIN IN SURVEY B-658-K AND SURVEY B-505-K IN WHICH HE MONUMENTED THE INTERSECTION OF "A" STREET AND FIFTH STREET AND MONUMENTED THE NORTH LINE OF TAX LOT 9200. GIVEN THE CHAIN OF DEEDS THE SCHOOL DISTRICT PROPERTY DESCRIPTION IS SENIOR AS IT WAS CONVEYED FROM KINCAID IN 1960 TO MORROW COUNTY SCHOOL DISTRICT NO. R-1 IN BK. 65, PG.517. KINCAID CONVEYED TO MILLER IN 1963 BK.69, PG.408 THE DESCRIPTION FOR TAX LOT 9200. THE SOLUTION TO THE BOUNDARY LOCATION BETWEEN THESE TWO PROPERTIES IS NOT AS SIMPLE AS A JUNIOR/SENIOR RELATIONSHIP AS A POTENTIAL ADVERSE CLAIM MIGHT BE HELD BY THE OWNER OF TAX LOT 9200 GIVEN THE ERRONEOUS MONUMENT LOCATION SET BY WAGNER AS STATED ABOVE WITH THE PRESENCE OF AN EXISTING FENCE BUILT TO SAID MONUMENT WHICH APPEARS TO BE THE OCCUPATION LINE IN GOOD FAITH BY THE EASTERLY ADJOINER. THIS SURVEY SHOWS THE EASTERLY BOUNDARY OF TAX LOT 7600 TO FOLLOW THE WESTERLY RIGHT-OF-WAY MARGIN OF CHERRY STREET UNTIL ITS INTERSECTION WITH THE SOUTHERLY RIGHT-OF-WAY MARGIN OF 5TH STREET WHERE IT JOGS WEST ALONG THE WESTERLY PROJECTION OF SAID SOUTHERLY MARGIN TO INTERSECT THE MONUMENTED EAST LINE OF TAX LOT 7600 PER WAGNER IN SURVEY C-1365-M, THENCE SOUTHERLY ALONG THE PROJECTION OF WAGNER'S LINE TO WILLOW CREEK.
