PARCEL 1 OF PARTITION PLAT NO. 2021-18, RECORDED MAY 27, 2021 AS DOCUMENT NO. 2021-48907, OFFICIAL RECORDS OF MORROW COUNTY, OREGON, LOCATED IN THE SOUTHWEST QUARTER (SW 1/4) OF SECTION 6, TOWNSHIP 4 NORTH, RANGE 26 EAST, WILLAMETTE MERIDIAN, MORROW COUNTY, OREGON.

SURVEY NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO SUBDIVIDE THE LAND SHOWN HEREON INTO TWO PARCELS AS CONDITIONED BY MORROW COUNTY PER LP-N-516-23 AND R-N-082-23.

THE INITIAL POINT OF THIS SURVEY IS THE SOUTHWEST CORNER OF PARCEL 1, PARTITION PLAT NUMBER 2021-18, MARKED WITH A 5/8" IRON ROD WITH YELLOW PLASTIC CAP STAMPED "ARMSTRONG SURVEYING". THIS PARTITION PLAT IS A SUBDIVISION OF SAID PARCEL 1, PARTITION PLAT NUMBER 2021-18, RECORDED AS INSTRUMENT NUMBER 2021-48907. IT WAS FOUND THAT THIS PARCEL HAS BEEN APART OF MULTIPLE PARTITION PLATS. THERE WERE MULTIPLE MONUMENTS FOUND FROM THESE VARIOUS PARTITION PLATS AS NOTED HEREON.

THE RIGHT-OF-WAY OF GAR SWANSON DRIVE, THE SOUTH LINE OF SAID RIGHT-OF-WAY BEING THE NORTH LINE OF PARCEL 1, PARTITION PLAT NUMBER 2021-18, WAS ESTABLISHED BY HOLDING THE RECORD ROAD DATA PER PARTITION PLAT NUMBER 2011-19 AND THE FOUND CENTERLINE MONUMENTS PER THE SAID PARTITION 2011-19. SAID MONUMENTS WERE FOUND WITHIN REASONABLE TOLERANCE WITH THE RECORD DATA OF SAID GAR SWANSON ROAD. THIS RESOLUTION AGREES WITH THE PLATTED ROAD WIDTH OF 100 FEET (50 FEET FROM CENTER) AND THE FOUND MONUMENTS ALONG THE SOUTH LINE OF SAID RIGHT-OF-WAY.

THE RIGHT-OF-WAY OF INTERNET PARKWAY, THE WEST LINE OF SAID RIGHT-OF-WAY BEING THE EAST LINE OF PARCELS 1, 2, AND 3, PARTITION PLAT NUMBER 2022-17, WAS ESTABLISHED BY HOLDING THE RECORD ROAD DATA PER PARTITION PLAT NUMBER 2011-19 AND THE FOUND CENTERLINE MONUMENTS PER SAID PARTITION PLAT 2011-19 AND THE SOUTH 1/4 CORNER OF SECTION 6. THE CENTERLINE OF SAID INTERNET PARKWAY IS SAID TO BE ON THE NORTH-SOUTH CENTER 1/4 LINE OF SAID SECTION 6. THE MONUMENTS ALONG SAID CENTERLINE WERE FOUND WITHIN REASONABLE TOLERANCE WITH THE RECORD DATA OF SAID INTERNET PARKWAY. THIS RESOLUTION AGREES WITH THE PLATTED ROAD WIDTH OF 100 FEET (50 FEET FROM CENTER) AND THE TWO (2) NORTHERN MOST FOUND MONUMENTS ALONG THE WEST LINE OF SAID RIGHT-OF-WAY.

IN PARTITION PLAT NUMBER 2022-17 (R13) THERE IS A SHOWN ANGLE POINT IN THE SAID RIGHT-OF-WAY OF INTERNET PARKWAY. THIS WAS LIKELY DUE TO HOLDING THE FOUND MONUMENTS SET IN SAID PARTITION PLAT NUMBER 2011-19 (R4). IT WAS FOUND THAT THE SOUTHEAST CORNER OF PARCEL 3, PARTITION PLAT NUMBER 2022-17 (R13), SET ORIGINALLY IN PARTITION PLAT NUMBER 2011-19 (R4), MAY HAVE BEEN DISTURBED. SAID MONUMENT BEARS SOUTH 14°18'44" WEST 1.18' FROM THE SAID SOUTHEAST CORNER AND ALSO FALLS 0.33' WEST OF THE SOUTHERLY EXTENSION OF SAID RIGHT-OF-WAY LINE. THE CORNER COMMON TO PARCELS 1 AND 2, AND THE CORNER COMMON TO PARCELS 2 AND 3, OF SAID PARTITION PLAT NUMBER 2022-17 (R13), WERE FOUND TO BE 0.39' AND 0.35', RESPECTIVELY, WEST OF THE SAID WEST RIGHT-OF-WAY LINE OF INTERNET PARKWAY. THESE MONUMENTS WERE NOT HELD AS A RESULT, AS INTERNET PARKWAY WAS INTENDED TO BE STRAIGHT AND CONTINUOUS.

THE RIGHT-OF-WAY OF LEWIS AND CLARK DRIVE, THE NORTH LINE BEING THE SOUTH LINE OF PARCEL 1, PARTITION PLAT NUMBER 2021-18, WAS ESTABLISHED BY HOLDING THE RECORD ROAD DATA OF PARTITION PLAT NUMBER 2011-19 (R4) AND THE FOUND MONUMENTS ALONG THE SOUTH LINE OF SECTION 6. SAID MONUMENTS WERE FOUND WITHIN REASONABLE TOLERANCE AND HELD AS ORIGINAL. THIS RESOLUTION AGREES WITH THE PLATTED ROAD WIDTH OF 100 FEET (50 FEET FROM CENTER) AND THE FOUND MONUMENTS ALONG THE NORTH LINE OF SAID RIGHT-OF-WAY.

THE WEST LINE OF PARCEL 1, PARTITION PLAT NUMBER 2021-18, BEING THE EAST LINE OF PARCEL 1, PARTITION PLAT NUMBER 2021-12, WAS ESTABLISHED BY HOLDING THE FOUND MONUMENTS PER PARTITION PLAT NUMBER 2021-18. SAID MONUMENTS WERE HELD AS ORIGINAL AND FIT WITHIN REASONABLE TOLERANCE. THIS RESOLUTION AGREES WITH THE ADJOINING PARCEL AND FITS RECORD DISTANCE WITHIN REASONABLE TOLERANCE.

NO OTHER UNUSUAL CIRCUMSTANCES WERE ENCOUNTERED DURING THE COURSE OF THIS SURVEY.


