

SURVEY NARRATIVE

THIS RECORD OF SURVEY HAS BEEN PREPARED AT THE REQUEST OF LARRY LUTCHER. THE PURPOSE IS TO SURVEY THAT PORTION OF REAL PROPERTY DESCRIBED UNDER M-30942 LOCATED WITHIN SECTION 8, ALSO KNOWN AS TAX LOT 2200 OF MAP 4S29E, AND TO INVESTIGATE EXISTING ACCESS TO THE PROPERTY.

CONTROLLING SECTION CORNER MONUMENTATION WAS FOUND AND HELD AS SHOWN HEREON. I MADE A SEARCH FOR THE NORTH AND EAST QUARTER CORNERS OF SECTION 8 BUT NO EVIDENCE COULD BE FOUND. I DETERMINE THESE CORNERS LOST AND COMPUTED THE SUBDIVISION OF SECTION 8 PER THE 2009 MANUAL OF SURVEYING INSTRUCTIONS, AND SURVEY FOLDER 1321.

THE NORTH AND EAST LINES OF THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 8 HAVE BEEN MARKED WITH T-POSTS AT VARIOUS INTERVALS AS REQUESTED BY MY CLIENT. THE COUNTY ROAD AND ACCESS ROAD AS MAPPED HEREON WAS COMPLETED BY COLLECTING DATA POINTS ALONG THE APPARENT CENTER OF ROAD, COLLECTED ON 5-21-2024. COUNTY ROAD RESEARCH INDICATES THIS ROAD ORIGINATES FROM PETITION #138B. I COULD FIND NO WIDTH STATED IN THE 1895 ESTABLISHMENT DOCUMENTS SO HAVE UTILIZED THE STANDARD ROAD WIDTH AT THAT TIME, 60 FEET. THE SOUTHERLY RIGHT-OF-WAY MARGIN OF THE COUNTY ROAD DOES INTERSECT THE NORTHWEST CORNER OF THE SUBJECT PROPERTY BUT DOES NOT ALLOW FOR ENOUGH FRONTAGE TO CONSTRUCT A DRIVEWAY WITHOUT EASEMENT CONSIDERATION.

THE EXISTING ACCESS ROAD IS CURRENTLY THE PRIMARY MEANS OF ACCESS TO THE PROPERTY AND IS ALSO USED BY OTHER AREA PROPERTY OWNERS. THE ROAD SEEMS TO BE PRESCRIPTIVE IN NATURE: THIS ROAD HAS BEEN IDENTIFIED BY MEASUREMENT IN PREPARATION FOR DEVELOPING A LEGAL DESCRIPTION WHICH MAY BE INCORPORATED INTO A FUTURE EASEMENT DOCUMENT.

THIS SURVEY WAS PERFORMED USING TWO TOPCON HIPER HR GNSS UNITS OPERATED USING RTK METHODS, AND A TOPCON GT-603 ROBOTIC TOTAL STATION. THE BASIS OF BEARING IS THE WEST LINE OF THE NW1/4 OF SECTION 8 PER SURVEY FOLDER 1321. DISTANCES ARE GROUND, INTERNATIONAL FEET.
